1.7	Section 1. [116J.4231] OFFICE OF NEW AMERICANS.
1.8	Subdivision 1. Office established; purpose. (a) The Office of New Americans is
1.9	established within the Department of Employment and Economic Development. The governor
1.10	must appoint an executive director who serves in the unclassified service. The executive
1.11	director must hire a program manager, an office assistant, and any staff necessary to carry
1.12	out the office's duties under subdivision 2.
1.13	(b) The purpose of the office is to serve immigrants and refugees in Minnesota by:
1.14	(1) addressing challenges that face immigrants and refugees in Minnesota;
1.15	(2) creating access in economic development and workforce programs and services; and
1.16	(3) providing interstate agency coordination, policy reviews, and guidance that assist in
1.17	creating access for immigrants and refugees.
1.18	Subd. 2. Duties. The Office of New Americans has the duty to:
