Minnesota Statutes 2019 Supplement, section 256.042, subdivision 2, is amended 1.6 to read: 1.7 Subd. 2. **Membership.** (a) The council shall consist of the following 19 28 voting 1.8 members, appointed by the commissioner of human services except as otherwise specified, 1.9 and three nonvoting members: 1.10 (1) two members of the house of representatives, appointed in the following sequence: 1.11 the first from the majority party appointed by the speaker of the house and the second from 1.12 the minority party appointed by the minority leader. Of these two members, one member 1.13 must represent a district outside of the seven-county metropolitan area, and one member 1.14 must represent a district that includes the seven-county metropolitan area. The appointment 1.15 by the minority leader must ensure that this requirement for geographic diversity in 1.16 appointments is met; 1.17 (2) two members of the senate, appointed in the following sequence: the first from the 1.18 majority party appointed by the senate majority leader and the second from the minority 1.19 party appointed by the senate minority leader. (b) The commissioner of human services shall coordinate the commissioner's appointments to provide geographic, racial, and gender diversity, and shall ensure that at least one-half of council members appointed by the commissioner reside outside of the seven-county metropolitan area. Of the members appointed by the commissioner, to the extent practicable, at least one member must represent a community of color disproportionately affected by the opioid epidemic.

- (c) The council is governed by section 15.059, except that members of the council shall receive no compensation other than reimbursement for expenses. Notwithstanding section 15.059, subdivision 6, the council shall not expire.
- (d) The chair shall convene the council at least quarterly, and may convene other meetings as necessary. The chair shall convene meetings at different locations in the state to provide geographic access, and shall ensure that at least one-half of the meetings are held at locations outside of the seven-county metropolitan area.
- (e) The commissioner of human services shall provide staff and administrative services for the advisory council.
