1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2014, section 129C.10, subdivision 1, is amended to read:
1.8	Subdivision 1. Governance. (a) The board of the Perpich Center for Arts Education
1.9	shall consist of <u>15</u> 13 persons, one of whom must have served as a school administrator or
1.10	as an elected school board member, one of whom is a locally or regionally recognized
1.11	professional artist, and one of whom is a secondary or postsecondary arts educator. The
1.12	members of the board shall be appointed by the governor with the advice and consent of
1.13	the senate. At least one member must be appointed from each congressional district.
1.14	(b) A seven-member nominating committee composed of three currently serving
1.15	members of the board of the Perpich Center for Arts Education appointed by the board,
1.16	one member appointed by the Minnesota Association of School Administrators, one
1.17	member appointed by the Minnesota State Arts Board, one member appointed by the
1.18	Minnesota School Boards Association, and one member appointed by the governor shall
1.19	meet at least 60 days before the date on which the next expiring board member's term is set
1.20	to expire or within 15 days of receiving notice of a board vacancy occurring at a time other
1.21	than at the end of a board member's term to prepare and submit a list of recommended
1.22	candidates to the governor for the governor to consider when appointing members of the
1.23	Perpich Center for Arts Education Board.
1.24	(c) All board members must complete board training requirements consistent with

- 2.21 Subd. 4. Audit report. (a) The Perpich Center for Arts Education is subject to an
 2.22 annual independent audit. The audit must be conducted in compliance with generally
- 2.23 accepted governmental auditing standards, and the Federal Single Audit Act, if applicable.
- 2.24 <u>The legislative auditor or Department of Education may conduct financial, program, or</u>
- 2.25 compliance audits, and may direct the Perpich Center for Arts Education to include any
- 2.26 <u>additional items in its annual independent audit.</u>
