1.6	Section 1. Minnesota Statutes 2018, section 171.13, subdivision 7, is amended to read:
1.7	Subd. 7. Repeat Examination fee fees. (a) A fee of \$10 must be paid by an individual
1.8	to take a third and any subsequent knowledge test administered by the department if the
1.9	individual has failed two previous consecutive knowledge tests on the subject.
1.10	(b) A fee of \$20 must be paid by an individual to take a third and any subsequent skills
1.11	or road test administered by the department if the individual has previously failed two
1.12	consecutive skill or road tests in a specified class of motor vehicle.
1.13	(c) <u>A fee of \$20 must be paid by an individual who fails to appear for a scheduled skills</u>
1.14	or road test, or who cancels a skills or road test within 24 hours of the appointment time.
1.15	(\underline{d}) All fees received under this subdivision must be paid into the state treasury and
1.16	credited to the driver services operating account in the special revenue fund specified under
