Sec. 3. **SECURITY TRAINING GRANT.**

\$50,000 in fiscal year 2023 is appropriated from the general fund to the commissioner of public safety for a grant to a nonprofit organization with experience promoting the security of nonprofit and interfaith organizations. The grant recipient shall work with faith-based institutions, including churches, synagogues, and mosques, to provide training to address emergency situations that involve an immediate threat to the lives or safety of individuals at those faith-based institutions. Money shall be used exclusively to contract with one or more experts to provide the training, and the training shall be provided at no additional cost to the faith-based institutions.
