1.6	Section 1. [15.0146] MINNESOTA HEALTH POLICY COMMISSION.
1.7	Subdivision 1. Establishment; purpose. The Minnesota Health Policy Commission is
1.8	created to provide recommendations on improving health care and health outcomes at lower
1.9	costs through commercial and public programs. For purposes of this section, "commission"
1.10	means the Minnesota Health Policy Commission.
1.11	Subd. 2. Commission membership. (a) The commission shall consist of 11 voting
1.12	members, appointed as follows:
1.13	(1) one member with demonstrated expertise in health care finance;
