1.3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.4	Section 1. CLEAN WATER FUND APPROPRIATIONS.
1.5	Subdivision 1. Pollution Control Agency. \$10,000 in fiscal year 2019 is appropriated
1.6	from the clean water fund to the commissioner of the Pollution Control Agency to support
1.7	activities of the Clean Water Council according to Minnesota Statutes, section 114D.30,
1.8	subdivision 1. This is a onetime appropriation.
1.9	Subd. 2. Department of Natural Resources. \$1,000,000 in fiscal year 2019 is
1.10	appropriated from the clean water fund to the commissioner of natural resources to acquire
1.11	permanent conservation easements in targeted areas to protect the forests and shorelands
1.12	that supply clean water to lakes, rivers, and streams under Minnesota Statutes, section 84.66.
1.13	This is a onetime appropriation and is available until June 30, 2022.
1.14	Subd. 3. Board of Water and Soil Resources. (a) \$4,412,000 in fiscal year 2019 is
1.15	appropriated from the clean water fund to the Board of Water and Soil Resources for a pilot
1.16	program to provide performance-based grants to local government units. The grants may
1.17	be used to implement projects that protect, enhance, and restore surface water quality in
1.18	lakes, rivers, and streams; protect groundwater from degradation; and protect sources of
1.19	drinking water. Projects must be identified in a comprehensive watershed plan developed
1.20	under the One Watershed, One Plan or metropolitan surface water management frameworks
1.21	or groundwater plans. Grant recipients must identify a nonstate match and may use other
1.22	legacy funds to supplement projects funded under this paragraph.
