A bill for an act 1.1 relating to taxation; income; providing a military retirement pay subtraction; 12 amending Minnesota Statutes 2012, sections 290.01, subdivision 19b; 290.091, 1.3 subdivision 2. 1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5 Section 1. Minnesota Statutes 2012, section 290.01, subdivision 19b, is amended to read: 1.6 Subd. 19b. Subtractions from federal taxable income. For individuals, estates, 1.7 and trusts, there shall be subtracted from federal taxable income: 1.8 (1) net interest income on obligations of any authority, commission, or 1.9 instrumentality of the United States to the extent includable in taxable income for federal 1.10 income tax purposes but exempt from state income tax under the laws of the United States; 1.11 (2) if included in federal taxable income, the amount of any overpayment of income 1.12 tax to Minnesota or to any other state, for any previous taxable year, whether the amount 1.13 is received as a refund or as a credit to another taxable year's income tax liability; 1.14 (3) the amount paid to others, less the amount used to claim the credit allowed under 1.15 section 290.0674, not to exceed \$1,625 for each qualifying child in grades kindergarten 1.16 to 6 and \$2,500 for each qualifying child in grades 7 to 12, for tuition, textbooks, and 1.17 transportation of each qualifying child in attending an elementary or secondary school 1.18 situated in Minnesota, North Dakota, South Dakota, Iowa, or Wisconsin, wherein a 1.19 resident of this state may legally fulfill the state's compulsory attendance laws, which 1.20 1.21 is not operated for profit, and which adheres to the provisions of the Civil Rights Act of 1964 and chapter 363A. For the purposes of this clause, "tuition" includes fees or 1 22 tuition as defined in section 290.0674, subdivision 1, clause (1). As used in this clause, 1.23 "textbooks" includes books and other instructional materials and equipment purchased 1.24

or leased for use in elementary and secondary schools in teaching only those subjects 2.1 legally and commonly taught in public elementary and secondary schools in this state. 2.2 Equipment expenses qualifying for deduction includes expenses as defined and limited in 2.3 section 290.0674, subdivision 1, clause (3). "Textbooks" does not include instructional 2.4 books and materials used in the teaching of religious tenets, doctrines, or worship, the 2.5 purpose of which is to instill such tenets, doctrines, or worship, nor does it include books 2.6 or materials for, or transportation to, extracurricular activities including sporting events, 2.7 musical or dramatic events, speech activities, driver's education, or similar programs. No 28 deduction is permitted for any expense the taxpayer incurred in using the taxpayer's or 2.9 the qualifying child's vehicle to provide such transportation for a qualifying child. For purposes of this clause, 2.25 "federal foreign tax credit" means the credit allowed under section 27 of the Internal 2.26 Revenue Code, and "carryover of subnational foreign taxes" equals the carryover allowed 2.27 under section 904(c) of the Internal Revenue Code minus national level foreign taxes to 2.28 the extent they exceed the federal foreign tax credit; 2.29

(8) in each of the five tax years immediately following the tax year in which an
addition is required under subdivision 19a, clause (7), or 19c, clause (15), in the case of a
shareholder of a corporation that is an S corporation, an amount equal to one-fifth of the
delayed depreciation. For purposes of this clause, "delayed depreciation" means the amount
of the addition made by the taxpayer under subdivision 19a, clause (7), or subdivision 19c,
clause (15), in the case of a shareholder of an S corporation, minus the positive value of

any net operating loss under section 172 of the Internal Revenue Code generated for the 3.1 tax year of the addition. The resulting delayed depreciation cannot be less than zero; 3.2 (9) job opportunity building zone income as provided under section 469.316;

(10) to the extent included in federal taxable income, the amount of compensation 3.4 paid to members of the Minnesota National Guard or other reserve components of the 3.5 United States military for active service, excluding compensation for services performed 3.6 under the Active Guard Reserve (AGR) program. For purposes of this clause, "active 3.7 service" means (i) state active service as defined in section 190.05, subdivision 5a, clause 3.8 (1); or (ii) federally funded state active service as defined in section 190.05, subdivision 3.9 5b, but "active service" excludes service performed in accordance with section 190.08, 3.10 subdivision 3; 3.11

(11) to the extent included in federal taxable income, the amount of compensation 3.12 paid to Minnesota residents who are members of the armed forces of the United States 3.13 or United Nations for active duty performed under United States Code, title 10; or the 3.14 authority of the United Nations; 3.15

(12) an amount, not to exceed \$10,000, equal to qualified expenses related to a 3.16 qualified donor's donation, while living, of one or more of the qualified donor's organs 3.17 to another person for human organ transplantation. For purposes of this clause, "organ" 3.18 means all or part of an individual's liver, pancreas, kidney, intestine, lung, or bone marrow; 3.19 "human organ transplantation" means the medical procedure by which transfer of a human 3.20 organ is made from the body of one person to the body of another person; "qualified 3.21 expenses" means unreimbursed expenses for both the individual and the qualified donor 3.22 for (i) travel, (ii) lodging, and (iii) lost wages net of sick pay, except that such expenses 3.23 may be subtracted under this clause only once; and "qualified donor" means the individual 3.24 or the individual's dependent, as defined in section 152 of the Internal Revenue Code. An 3.25 individual may claim the subtraction in this clause for each instance of organ donation for 3.26 transplantation during the taxable year in which the qualified expenses occur; 3.27
