1.29 Subd. 2d. SARSr-CoV infection control. (a) A boarding care home must establish and

1.30 maintain a comprehensive SARSr-CoV infection control program that complies with accepted

1.31 health care, medical, and nursing standards for infection control according to the most

1.32 current SARS-CoV-2 infection control guidelines or their successor versions issued by the

United States Centers for Disease Control and Prevention, Centers for Medicare and Medicaid Services, and the commissioner. This program must include a SARSr-CoV infection control plan that covers all paid and unpaid employees, contractors, students, volunteers, residents, and visitors. The commissioner shall provide technical assistance regarding implementation of the guidelines.

(b) The boarding care home must maintain written evidence of compliance with this subdivision.

EFFECTIVE DATE. This section is effective the day following final enactment.

Subd. 2e. **Severe acute respiratory syndrome-related coronavirus response plan.** (a) A boarding care home must establish, implement, and maintain a severe acute respiratory syndrome-related coronavirus response plan. The severe acute respiratory syndrome-related coronavirus response plan must be consistent with the requirements of subdivision 2d and at a minimum must address the following:

(1) baseline and serial SARSr-CoV testing of all paid and unpaid employees, contractors, students, volunteers, residents, and visitors;

(2) use of personal protective equipment by all paid and unpaid employees, contractors, students, volunteers, residents, and visitors;

(3) separation or isolation of residents infected with SARS-CoV-2 or a similar SARSr-CoV from residents who are not;

(4) balancing the rights of residents with controlling the spread of SARS-CoV-2 or similar SARSr-CoV infections;

(5) resident relocations, including steps to be taken to mitigate trauma for relocated residents receiving memory care;

(6) clearly informing residents of the boarding care home's policies regarding the effect of hospice orders, provider orders for life-sustaining treatment, do not resuscitate orders, and do not intubate orders on any treatment of COVID-19 disease or similar severe acute respiratory syndromes;

(7) mitigating the effects of separation or isolation of residents, including virtual visitation, outdoor visitation, and for residents who cannot go outdoors, indoor visitation;

(8) compassionate care visitation;

(9) consideration of any campus model, multiple buildings on the same property, or any mix of independent senior living units in the same building as assisted living units;

(10) steps to be taken when a resident is suspected of having a SARS-CoV-2 or similar SARSr-CoV infection;

(11) steps to be taken when a resident tests positive for a SARS-CoV-2 or similar SARSr-CoV infection;

(12) protocols for emergency medical responses involving residents with SARS-CoV-2 or similar SARSr-CoV infections, including infection control procedures following the departure of ambulance service personnel or other first responders;

(13) notifying the commissioner when staffing levels are critically low; and

(14) taking into account dementia-related concerns.

(b) A boarding care home must provide the commissioner with a copy of a severe acute respiratory syndrome-related coronavirus response plan meeting the requirements of this subdivision.

(c) A boarding care home must make its severe acute respiratory syndrome-related coronavirus response plan available to staff, residents, and families of residents.

Subd. 3. **Consent to electronic monitoring.** (a) Except as otherwise provided in this subdivision, a resident must consent to electronic monitoring in the resident's room or private living unit in writing on a notification and consent form. If the resident has not affirmatively objected to electronic monitoring and the resident representative attests that the resident's medical professional ~~determines~~ determined that the resident currently lacks the ability to understand and appreciate the nature and consequences of electronic monitoring, the resident representative may consent on behalf of the resident. For purposes of this subdivision, a resident affirmatively objects when the resident orally, visually, or through the use of auxiliary aids or services declines electronic monitoring. The resident's response must be documented on the notification and consent form.

(b) Prior to a resident representative consenting on behalf of a resident, the resident must be asked if the resident wants electronic monitoring to be conducted. The resident representative must explain to the resident:

- 4.1 (1) the type of electronic monitoring device to be used;
- 4.2 (2) the standard conditions that may be placed on the electronic monitoring device's use,
- 4.3 including those listed in subdivision 6;
- 4.4 (3) with whom the recording may be shared under subdivision 10 or 11; and
- 4.5 (4) the resident's ability to decline all recording.
- 4.6 (c) A resident, or resident representative when consenting on behalf of the resident, may
- 4.7 consent to electronic monitoring with any conditions of the resident's or resident
- 4.8 representative's choosing, including the list of standard conditions provided in subdivision
- 4.9 6. A resident, or resident representative when consenting on behalf of the resident, may
- 4.10 request that the electronic monitoring device be turned off or the visual or audio recording
- 4.11 component of the electronic monitoring device be blocked at any time.

36.27 nursing homes, boarding care homes, and long-term acute care hospitals must not discharge
36.28 or transfer residents except for transfers in accordance with guidance issued by the Centers
36.29 for Disease Control and Prevention, the Centers for Medicare and Medicaid Services, and
36.30 the Minnesota Department of Health for the purposes of controlling SARS-CoV-2 infections,
36.31 or unless the failure to discharge or transfer the resident would endanger the health or safety
36.32 of the resident or other individuals in the facility.

Subd. 4. **Pending discharge and transfer appeals.** For the duration of the peacetime emergency declared in Executive Order 20-01 or until Executive Order 20-01 is rescinded, final decisions on appeals of transfers and appeals under section 52, subdivisions 5 to 11, and Minnesota Statutes, section 144A.135, are stayed.

Subd. 5. **Penalties.** A person who willfully violates subdivisions 2 and 3 of this section is guilty of a misdemeanor and upon conviction must be punished by a fine not to exceed \$1,000, or by imprisonment for not more than 90 days.

EFFECTIVE DATE. This section is effective the day following final enactment.

Sec. 47. **TRANSFERS FOR COHORTING PURPOSES DURING THE COVID-19 PEACETIME EMERGENCY.**

Subdivision 1. **Definitions.** (a) The definitions in this subdivision apply to this section.

(b) "Dedicated COVID-19 care site" means:

(1) a dedicated facility for the care of individuals who have SARS-CoV-2 or similar infections; and

(2) dedicated locations in a facility for the care of individuals who have SARS-CoV-2 or similar infections.

(c) "Facility" means:

(1) a housing with services establishment registered under Minnesota Statutes, section 144D.02, and operating under title protection under Minnesota Statutes, sections 144G.01 to 144G.07;

(2) a housing with services establishment registered under Minnesota Statutes, section 144D.02, and required to disclose special care status under Minnesota Statutes, section 325F.72;

(3) a nursing home licensed under Minnesota Statutes, chapter 144A; or

(4) a boarding care home licensed under Minnesota Statutes, sections 144.50 to 144.58. Facility does not mean a hospital.

(d) "Resident" means:

(1) a person residing in a nursing home;

(2) a person residing in a boarding care home;

(3) a housing with services resident who receives assisted living that is subject to the requirements of Minnesota Statutes, sections 144G.01 to 144G.07; or

(4) a resident of a housing with services establishment required to disclose special care status under Minnesota Statutes, section 325F.72.

Subd. 2. Prohibited transfers and discharges. A hospital may not discharge or transfer any patient who previously tested positive for SARS-CoV-2, regardless of the patient's symptoms, to a facility other than a dedicated COVID-19 care site, unless the hospital documents a test confirming the patient does not have a SARS-CoV-2 infection.

Subd. 3. Transfers for cohorting purposes. (a) A facility may transfer a resident to another facility or location in a facility for the following cohorting purposes:

(1) transferring residents with symptoms of a respiratory infection or confirmed diagnosis of COVID-19 to a dedicated COVID-19 care site; or

(2) transferring residents without symptoms of a respiratory infection or confirmed diagnosis of COVID-19 or related infection to another facility or location in a facility dedicated to caring for such residents and preventing them from acquiring COVID-19 for the purposes of creating a dedicated COVID-19 care site.

The transferring facility must receive confirmation that the receiving facility agrees to accept the resident to be transferred. Confirmation may be in writing or oral. If verbal, the transferring facility must document who from the receiving facility communicated agreement and the date and time this person communicated agreement.

(b) A spouse who resides with a transferred resident may elect to accompany the transferred resident to the receiving facility to continue to reside with the resident transferred for cohorting purposes. The transferring facility must disclose to the spouse of the transferred resident the known risks to the spouse of accompanying the resident to the receiving facility.

Subd. 4. Required cohorting practices. (a) A facility must cohort residents with positive tests for SARS-CoV-2, regardless of symptoms, in a dedicated COVID-19 care site until such time as a resident has a confirmed negative test for SARS-CoV-2. A resident with a confirmed negative test for SARS-CoV-2 may return to the facility or room from which the resident was transferred, provided the facility or room is not a dedicated COVID-19 care site.

(b) A facility that establishes a dedicated COVID-19 care site must dedicate staff, supplies, and equipment exclusively to either the dedicated COVID-19 care site or to the part of the facility that is not a dedicated COVID-19 care site. A facility must not permit

39.1 staff, supplies, or equipment to move between a dedicated COVID-19 care site and a building
39.2 or part of a facility that is not a dedicated COVID-19 care site.

39.3 (c) A facility must not permit a resident with a positive test for SARS-CoV-2 to share
39.4 a room or living unit with a resident who is not SARS-CoV-2 positive, unless the residents
39.5 are spouses or otherwise provide informed consent.

39.6 Subd. 5. **Notice required.** A transferring facility shall provide the transferred resident

39.11 (3) the name and contact information of a representative of the transferring facility with

39.14 whom the resident may discuss the transfer;

39.15 (5) a statement that the transferring facility will participate in a coordinated move and
39.16 transfer of the care of the resident to the receiving facility, as required under section 52,
39.17 subdivision 16, and under Minnesota Statutes, section 144A.44, subdivision 1, clause (18);

39.18 (6) a statement that a transfer for cohorting purposes does not constitute a termination
39.19 of a lease, services, or a service plan; and

39.20 (7) a statement that a resident has a right to return to the transferring facility as provided
39.21 under subdivision 11.

39.22 Subd. 6. **Waived transfer requirements for cohorting purposes.** The following
39.23 requirements related to rights of residents, as defined in subdivision 1, paragraph (d), clauses
39.24 (3) and (4), are waived, or modified as indicated, only for purposes related to transfers to
39.25 another facility under subdivision 3:

39.26 (1) the right to take an active part in developing, modifying, and evaluating the plan and
39.27 services under Minnesota Statutes, section 144A.44, clause (2);

39.28 (2) rights under Minnesota Statutes, section 144A.44, clause (3);

39.29 (3) rights under Minnesota Statutes, section 144A.44, clause (4);

39.30 (4) rights under Minnesota Statutes, section 144A.44, clause (9);

39.31 (5) rights under Minnesota Statutes, section 144A.44, clause (15);

40.1 (6) timelines for completing assessments under Minnesota Statutes, section 144A.4791,
40.2 subdivision 8. A receiving facility must complete client assessments following a transfer
40.3 for cohorting purposes as soon as practicable; and

40.4 (7) timelines for completing service plans under Minnesota Statutes, section 144A.4791,
40.5 subdivision 9. A receiving facility must complete client service plans following a transfer
40.6 for cohorting purposes as soon as practicable and must review and use the care plan for a
40.7 transferred client provided by the transferring facility, adjusting it as necessary to protect
40.8 the health and safety of the client.

40.9 Subd. 7. **Mandatory transfer of medical assistance clients for cohorting purposes.** (a)
40.10 The commissioner of health has the authority to transfer medical assistance residents to
40.11 another facility for the purposes under subdivision 3.

40.12 (b) The commissioner of human services may not deny reimbursement to a facility
40.13 receiving a resident under this section for a private room or private living unit.

40.14 Subd. 8. **Coordinated transfer required.** Nothing in this section shall be considered
40.15 inconsistent with a resident's right to a coordinated move and transfer of care as required
40.16 under section 52, subdivision 16.

40.17 Subd. 9. **Transfers not considered terminations.** Nothing in this section shall be
40.18 considered inconsistent with a resident's rights under sections 46 and 52. A transfer under
40.19 this section is not a termination of a lease, services, or a service plan under section 46 or
40.20 52.

40.21 Subd. 10. **No right of appeal.** A resident may not appeal a transfer under subdivision
40.22 3.

40.23 Subd. 11. **Right to return.** If a resident is absent from a facility as a result of a transfer
40.24 under subdivision 3, the facility must allow a resident to return to the transferring facility,
40.25 provided the resident is determined not to be infectious according to current medical
40.26 standards.

40.27 Subd. 12. **Appropriate transfers.** The commissioner of health shall monitor all transfers
40.28 made under this section. The commissioner may audit transfers made under this section for
40.29 compliance with the requirements of this section and may take enforcement actions for
40.30 violations, including issuing fines. A violation of this section as applied to a resident is at
40.31 least a level 2 violation as defined in Minnesota Statutes, section 144A.474.

41.1 Subd. 13. **Expiration.** Subdivisions 1 to 9 expire 60 days after the peacetime emergency
41.2 declared by the governor under Minnesota Statutes, section 12.31, subdivision 2, for an
41.3 outbreak of COVID-19, is terminated or rescinded by proper authority.

41.4 **EFFECTIVE DATE.** This section is effective the day following final enactment.

41.5 Sec. 48. **LONG-TERM CARE SEVERE ACUTE RESPIRATORY**
41.6 **SYNDROME-RELATED CORONAVIRUS TASK FORCE.**

41.7 Subdivision 1. **Membership.** (a) A Long-Term Care Severe Acute Respiratory
41.8 Syndrome-Related Coronavirus Task Force consists of the following members:

41.9 (1) two senators, including one senator appointed by the senate majority leader and one
41.10 senator appointed by the senate minority leader, who shall each be ex officio nonvoting
41.11 members;

41.12 (2) two members of the house of representatives, including one member appointed by
41.13 the speaker of the house and one member appointed by the minority leader of the house of
41.14 representatives, who shall each be ex officio nonvoting members;

41.15 (3) four family members of an assisted living client or of a nursing home resident,
41.16 appointed by the governor;

41.17 (4) four assisted living clients or nursing home residents, appointed by the governor;

41.18 (5) one medical doctor board-certified in infectious disease, appointed by the Minnesota
41.19 Medical Association;

41.20 (6) two medical doctors board-certified in geriatric medicine, appointed by the Minnesota
41.21 Network of Hospice and Palliative Care;

41.24 Assisted Living Nurses Association;

41.25 (8) two licensed practical nurses who provide care in a nursing home or assisted living
41.26 services, appointed by the Minnesota Chapter of the American Assisted Living Nurses

41.28 (9) one certified home health aide providing assisted living services or one certified
41.29 nursing assistant providing care in a nursing home, appointed by the Minnesota Home Care
41.30 Association;

42.1 (10) one personal care assistant who provides care in a nursing home or a facility in
42.2 which assisted living services are provided;

42.3 (11) one medical director of a licensed nursing home, appointed by the Minnesota
42.4 Association of Geriatrics Inspired Clinicians;

42.5 (12) one medical director of a licensed hospice provider, appointed by the Minnesota
42.6 Association of Geriatrics Inspired Clinicians;

42.7 (13) one licensed nursing home administrator, appointed by the Minnesota Board of
42.8 Executives for Long Term Services and Supports;

42.9 (14) one licensed assisted living director, appointed by the Minnesota Board of Executives
42.10 for Long Term Services and Support;

42.11 (15) two representatives of organizations representing long-term care providers, one
42.12 appointed by LeadingAge Minnesota and one appointed by Care Providers of Minnesota;

42.13 (16) one representative of a corporate owner of a licensed nursing home or of a housing
42.14 with services establishment operating under Minnesota Statutes, chapter 144G, assisted
42.15 living title protection, appointed by the Minnesota HomeCare Association;

42.16 (17) two representatives of an organization representing clients or families of clients
42.17 receiving assisted living services or residents or families of residents of nursing homes, one
42.18 appointed by Elder Voices Family Advocates and one appointed by AARP Minnesota;

42.19 (18) one representative of an organization representing clients and residents living with
42.20 dementia, appointed by the Minnesota-North Dakota Chapter of the Alzheimer's Association;

42.21 (19) one representative of an organization representing people experiencing maltreatment,
42.22 appointed by the Minnesota Elder Justice Center;

42.23 (20) one attorney specializing in housing law, appointed by Mid-Minnesota Legal Aid,
42.24 Southern Minnesota Regional Legal Services;

42.25 (21) one attorney specializing in elder law or disability benefits law, appointed by the
42.26 Governing Council of the Elder Law Section of the Minnesota State Bar Association;

42.27 (22) one chaplain in a long-term care setting, appointed by the Association of Professional
42.28 Chaplains (Minnesota);

42.29 (23) the commissioner of human services or a designee, who shall be an ex officio
42.30 nonvoting member;

(24) the commissioner of health or a designee, who shall be an ex officio nonvoting member; and

(25) the ombudsman for long-term care or designee, who shall be an ex officio nonvoting member.

(b) Appointing authorities must make initial appointments to the Long-Term Care Severe Acute Respiratory Syndrome-Related Coronavirus Task Force by August 1, 2020.

Subd. 2. Duties. The Long-Term Care Severe Acute Respiratory Syndrome-Related Coronavirus Task Force is established to study various methods of balancing the rights of assisted living clients and nursing home residents with the risk of outbreaks of SARS-CoV-2 or similar SARSr-CoV infections and COVID-19 disease or similar severe acute respiratory syndromes, and to advise the commissioners of health and human services on the use of their temporary emergency authorities with respect to providing long-term care during a peacetime emergency related to a severe acute respiratory syndrome-related coronavirus or severe acute respiratory syndromes. Goals of the task force are to minimize the number of deaths in long-term care facilities resulting from COVID-19 disease or similar severe acute respiratory syndromes and to alleviate isolation. At a minimum, the task force must study:

(1) how to minimize isolating assisted living clients and nursing home residents who are neither suspected or confirmed to have active SARS-CoV-2 or similar SARSr-CoV infections;

(2) how to separate assisted living clients and nursing home residents who are suspected or confirmed to have active SARS-CoV-2 or similar SARSr-CoV infections from those clients and residents who are neither suspected or confirmed to have active SARS-CoV-2 or similar SARSr-CoV infections;

(3) how to create facilities dedicated to caring for assisted living clients and nursing home residents with symptoms of a respiratory infection or confirmed diagnosis of COVID-19 disease or similar severe acute respiratory syndromes;

(4) how to create facilities dedicated to caring for assisted living clients and nursing home residents without symptoms of a respiratory infection or confirmed not to have COVID-19 disease or similar severe acute respiratory syndromes to prevent them from acquiring COVID-19 disease or similar severe acute respiratory syndromes;

(5) how to create facilities dedicated to caring for, isolating, and observing for up to 14 days assisted living clients and nursing home residents with known exposure to SARS-CoV-2 or a similar SARSr-CoV; and

44.1 (6) best practices related to executing hospice orders, provider orders for life-sustaining
44.2 treatment, do not resuscitate orders, and do not intubate orders when treating an assisted
44.3 living or nursing home resident for COVID-19 disease or similar severe acute respiratory
44.4 syndromes.

44.5 Subd. 3. **Advisory opinions.** The task force may issue advisory opinions to the
44.6 commissioners of health and human services regarding the commissioners' use of temporary
44.7 emergency authorities granted under emergency executive orders and in law, as well as
44.8 under any existing nonemergency authorities. The task force shall elect by majority vote
44.9 an author of each advisory opinion. The task force shall forward any advisory opinions it
44.10 issues to the chairs and ranking minority members of the legislative committees with
44.11 jurisdiction over health and human services policy and finance.

44.12 Subd. 4. **Report.** By January 15, 2021, the task force must report to the chairs and

48.4 maintain a comprehensive COVID-19 infection control program according to the most

48.14 appeal an imposed fine under the contested case procedure in Minnesota Statutes, section
48.15 144A.475, subdivisions 3a, 4, and 7. Fines collected under this section shall be deposited
48.16 in the state treasury and credited to the state government special revenue fund. Continued
48.17 noncompliance with the requirements of this section may result in revocation or nonrenewal
48.18 of facilities' license or registration. The commissioner shall make public the list of all
48.19 facilities that are not in compliance with this section.

48.20 Subd. 3. **Baseline testing grants.** Within the limits of money specifically appropriated
48.21 to the commissioner of human services under section 53, paragraph (a), the commissioner
48.22 of human services shall make COVID-19 baseline testing grants to any facility that has not
48.23 completed COVID-19 baseline testing. The commissioner shall determine the amount of
48.24 each baseline screening grant, and shall award a grant only if funds are not otherwise
48.25 available.

48.26 Subd. 4. **Serial screening reimbursement.** (a) Within the limits of money specifically
48.27 appropriated to the commissioner of human services under section 53, paragraph (b), the
48.28 commissioner of human services shall reimburse each facility for the allowable costs of
48.29 eligible COVID-19-related testing services that a facility cannot otherwise afford upon
48.30 submission by a facility of a COVID-19-related testing services cost report.

48.31 (b) The commissioner of human services shall develop a COVID-19-related testing
48.32 services cost report.

(c) A facility may submit a COVID-19-related testing services cost report once per month. If the commissioner of human services determines that a facility is in financial crisis, the facility may submit a cost report once every two weeks.

EFFECTIVE DATE. This section is effective the day following final enactment.

Sec. 52. **CONSUMER PROTECTIONS FOR ASSISTED LIVING CLIENTS.**

Subdivision 1. **Definitions.** (a) The definitions in this subdivision apply to this section.

(b) "Appropriate service provider" means an arranged home care provider that can adequately provide to a client the services agreed to in the service agreement.

(c) "Arranged home care provider" has the meaning given in Minnesota Statutes, section 144D.01, subdivision 2a.

(d) "Client" has the meaning given in Minnesota Statutes, section 144G.01, subdivision 3.

(e) "Client representative" means one of the following in the order of priority listed, to the extent the person may reasonably be identified and located:

(1) a court-appointed guardian acting in accordance with the powers granted to the guardian under Minnesota Statutes, chapter 524;

(2) a conservator acting in accordance with the powers granted to the conservator under Minnesota Statutes, chapter 524;

(3) a health care agent acting in accordance with the powers granted to the health care agent under Minnesota Statutes, chapter 145C;

(4) an attorney-in-fact acting in accordance with the powers granted to the attorney-in-fact by a written power of attorney under Minnesota Statutes, chapter 523; or

(5) a person who:

(i) is not an agent of a facility or an agent of a home care provider; and

(ii) is designated by the client orally or in writing to act on the client's behalf.

(f) "Facility" means:

(1) a housing with services establishment registered under Minnesota Statutes, section 144D.02, and operating under title protection under Minnesota Statutes, sections 144G.01 to 144G.07; or

50.1 (2) a housing with services establishment registered under Minnesota Statutes, section
50.2 144D.02, and required to disclose special care status under Minnesota Statutes, section
50.3 325F.72.

50.4 (g) "Home care provider" has the meaning given in Minnesota Statutes, section 144A.43,
50.5 subdivision 4.

50.6 (h) "Safe location" means a location that does not place a client's health or safety at risk.
50.7 A safe location is not a private home where the occupant is unwilling or unable to care for
50.8 the client, a homeless shelter, a hotel, or a motel.

50.9 (i) "Service plan" has the meaning given in Minnesota Statutes, section 144A.43,
50.10 subdivision 27.

50.11 (j) "Services" means services provided to a client by a home care provider according to
50.12 a service plan.

50.13 Subd. 2. **Prerequisite to termination; meeting.** (a) A facility and the arranged home
50.14 care provider must schedule and participate in a meeting with the client and the client
50.15 representative before the arranged home care provider issues a notice of termination of
50.16 services.

50.17 (b) A facility must schedule and participate in a meeting with the client and client
50.18 representative before the facility issues a termination of housing.

50.19 (c) The purposes of the meeting required under paragraph (a) are to:

50.20 (1) explain in detail the reasons for the proposed termination; and

50.21 (2) identify and offer reasonable accommodations or modifications, interventions, or
50.22 alternatives to avoid the termination including but not limited to securing services from
50.23 another home care provider of the client's choosing. A facility or arranged home care provider
50.24 is not required to offer accommodations, modifications, interventions, or alternatives that
50.25 fundamentally alter the nature of the operation of the facility or arranged home care provider.

50.26 (d) The meeting required under paragraph (a) must be scheduled to take place at least
50.27 seven days before a notice of termination is issued. The facility or arranged home care
50.28 provider, as applicable, must make reasonable efforts to ensure that the client and the client
50.29 representative are able to attend the meeting.

50.30 Subd. 3. **Pretermination meeting; notice.** (a) The arranged home care provider, the
50.31 facility, or both, as applicable, must provide written notice of the meeting to the client and
50.32 the client's representative at least five business days in advance.

51.1 (b) For a client who receives home and community-based waiver services under
51.2 Minnesota Statutes, section 256B.49, and chapter 256S, the arranged home care provider
51.3 must provide written notice of the meeting to the client's case manager at least five business
51.4 days in advance.

51.5 (c) The meeting must be scheduled to take place at least seven calendar days before a
51.6 notice of termination is issued. The arranged home care provider, in collaboration with the
51.7 facility, must make reasonable efforts to ensure that the client and the client's representative
51.8 are able to attend the meeting.

51.9 (d) The written notice under paragraphs (a) and (b) must include:

51.10 (1) the time, date, and location of the meeting;

51.11 (2) a detailed explanation of the reasons for the proposed termination;

51.12 (3) a list of facility and arranged home care provider representatives who will attend the
51.13 meeting;

51.14 (4) an explanation that the client may invite family members, representatives, health
51.15 professionals, and other individuals to participate in the meeting;

51.16 (5) contact information for the Office of Ombudsman for Long-Term Care and the Office
51.17 of Ombudsman for Mental Health and Developmental Disabilities with a statement that the
51.18 ombudsman offices provide advocacy services to clients;

51.19 (6) the name and contact information of an individual at the facility whom the client
51.20 may contact about the meeting or to request an accommodation;

51.21 (7) notice that attendees may request reasonable accommodations if the client has a
51.22 communication disability or speaks a language other than English;

51.23 (8) notice that if the client's housing or services are terminated, the client has the right
51.24 to appeal under subdivision 10; and

51.25 (9) notice that the client may invite family members, health professionals, a representative
51.26 of the Office of Ombudsman for Long-Term Care, or other persons of the client's choosing
51.27 to attend the meeting. For clients who receive home and community-based waiver services
51.28 under Minnesota Statutes, section 256B.49, and chapter 256S, the facility must notify the
51.29 client's case manager of the meeting.

51.30 (e) The arranged home care provider and the facility must provide written notice to the
51.31 client, the client's representative, and the client's case manager of any change to the date,
51.32 time, or location of the pretermination meeting.

52.1 Subd. 4. **Pretermination meeting requirements; identifying and offering**

52.2 **accommodations, modifications, and alternatives.** (a) At the meeting described in
52.3 subdivision 2, the arranged home care provider, the facility, or both, as applicable, must:

52.4 (1) explain in detail the reasons for the proposed termination; and

52.5 (2) collaborate with the client and the client's representative, case manager, and any
52.6 other individual invited by the client, to identify and offer any potential reasonable
52.7 accommodations, modifications, interventions, or alternatives that can address the issue
52.8 identified in clause (1).

52.9 (b) Within 24 hours after the conclusion of the meeting, the arranged home care provider,
52.10 the facility, or both, as applicable, must provide the client with a written summary of the
52.11 meeting, including any agreements reached about any accommodation, modification,
52.12 intervention, or alternative that will be used to avoid termination.

52.13 Subd. 5. **Emergency-relocation notice.** (a) A facility may remove a client from the
52.14 facility in an emergency if necessary due to a client's urgent medical needs or if the client
52.15 poses an imminent risk to the health or safety of another client, arranged home care provider
52.16 staff member, or facility staff member. An emergency relocation is not a termination.

52.17 (b) In the event of an emergency relocation, the facility, in coordination with the arranged
52.18 home care provider, must provide a written notice that contains, at a minimum:

52.19 (1) the reason for the relocation;

52.20 (2) the name and contact information for the location to which the client has been
52.21 relocated and any new service provider;

52.22 (3) the contact information for the Office of Ombudsman for Long-Term Care;

52.23 (4) if known and applicable, the approximate date or ranges of dates within which the
52.24 client is expected to return to the facility, or a statement that a return date is not currently
52.25 known; and

52.26 (5) a statement that, if the facility or arranged home care provider refuse to provide either
52.27 housing or services after a relocation, the client has a right to appeal under subdivision 10.
52.28 The facility, in coordination with the arranged home care provider, must provide contact
52.29 information for the agency to which the resident may submit an appeal.

52.30 (c) The notice required under paragraph (b) must be delivered as soon as practicable to:

52.31 (1) the client and the client's representative;

53.1 (2) for residents who receive home and community-based waiver services under
53.2 Minnesota Statutes, section 256B.49, and chapter 256S, the client's case manager; and

53.3 (3) the Office of Ombudsman for Long-Term Care if the client has been relocated and
53.4 has not returned to the facility within four days.

53.5 (d) Following an emergency relocation, a facility or an arranged home care provider's
53.6 refusal to provide housing or services, respectively, constitutes a termination and triggers
53.7 the termination process in this section.

53.8 (e) When an emergency relocation triggers the termination process and an in-person
53.9 meeting as described in subdivision 5 is impractical or impossible, the facility and arranged
53.10 home care provider may use telephonic, video, or other electronic format.

53.11 (f) If the meeting is held through telephone, video, or other electronic format, the facility
53.12 and arranged home care provider must ensure that the client, the client's representative, and
53.13 any case manager or representative of an ombudsman's office are able to participate in the
53.14 meeting. The facility and arranged home care provider must make reasonable efforts to
53.15 ensure that any person the client invites to the meeting is able to participate.

53.16 (g) The facility and arranged home care provider must issue the notice in this subdivision
53.17 at least 24 hours in advance of the meeting. The notice must include detailed instructions
53.18 on how to access the means of communication for the meeting.

53.19 (h) If notice to the ombudsman is required under paragraph (c), clause (3), the arranged
53.20 home care provider, the facility, or both, as applicable, must provide the notice no later than
53.21 24 hours after the notice requirement is triggered.

53.22 Subd. 6. **Restrictions on housing terminations.** (a) A facility may not terminate housing
53.23 except as provided in this subdivision.

53.24 (b) Upon 30 days' prior written notice, a facility may initiate a termination of housing
53.25 only for:

53.26 (1) nonpayment of rent, provided the facility informs the client that public benefits may
53.27 be available and provides contact information for the Senior LinkAge Line under Minnesota
53.28 Statutes, section 256.975, subdivision 7. An interruption to a client's public benefits that
53.29 lasts for no more than 60 days does not constitute nonpayment; or

53.30 (2) a violation of a lawful provision of housing if the client does not cure the violation
53.31 within a reasonable amount of time after the facility provides written notice to the client of
53.32 the ability to cure. Written notice of the ability to cure may be provided in person or by first
53.33 class mail. A facility is not required to provide a client with written notice of the ability to

54.1 cure for a violation that threatens the health or safety of the client or another individual in
54.2 the facility, including the staff of the arranged home care provider, or for a violation that
54.3 constitutes illegal conduct.

54.4 (c) Upon 15 days' prior written notice, a facility may terminate housing only if the client
54.5 has:

54.6 (1) engaged in conduct that substantially interferes with the rights, health, or safety of
54.7 other clients;

54.8 (2) engaged in conduct that substantially and intentionally interferes with the safety or
54.9 physical health of the staff of the arranged home care provider, the facility, or both, as
54.10 applicable; or

54.11 (3) committed an act listed in Minnesota Statutes, section 504B.171, that substantially
54.12 interferes with the rights, health, or safety of other clients.

54.13 (d) Nothing in this subdivision affects the rights and remedies available to facilities and
54.14 clients under Minnesota Statutes, chapter 504B.

54.15 Subd. 7. **Restrictions on terminations of services.** (a) An arranged home care provider
54.16 may not terminate services of a client in a facility except as provided in this subdivision.

54.17 (b) Upon 30 days' prior written notice, an arranged home care provider may initiate a
54.18 termination of services for nonpayment if the client does not cure the violation within a
54.19 reasonable amount of time after the arranged home care provider provides written notice
54.20 to the client of the ability to cure. An interruption to a client's public benefits that lasts for
54.21 no more than 60 days does not constitute nonpayment.

54.22 (c) Upon 15 days' prior written notice, an arranged home care provider may terminate
54.23 services only if:

54.24 (1) the client has engaged in conduct that substantially interferes with the client's health
54.25 or safety;

54.26 (2) the client's assessed needs exceed the scope of services agreed upon in the service
54.27 plan and are not otherwise offered by the arranged home care provider; or

54.28 (3) extraordinary circumstances exist, causing the arranged home care provider to be
54.29 unable to provide the client with the services agreed to in the service plan that are necessary
54.30 to meet the client's needs.

54.31 Subd. 8. **Notice of termination required.** (a) An arranged home care provider, a facility,
54.32 or both, as applicable, must issue a written notice of termination according to this subdivision.

55.1 The facility and arranged home care provider must send a copy of the termination notice to
55.2 the Office of Ombudsman for Long-Term Care and, for residents who receive home and
55.3 community-based services under Minnesota Statutes, section 156B. 49, and chapter 256S,
55.4 to the client's case manager, as soon as practicable after providing notice to the client. A
55.5 facility and arranged home care provider may terminate housing, services, or both, only as
55.6 permitted under subdivisions 8 and 9.

55.7 (b) A facility terminating housing under subdivision 6, paragraph (b), must provide a
55.8 written termination notice at least 30 days before the effective date of the termination to the
55.9 client and the client's representative.

55.10 (c) A facility terminating housing under subdivision 6, paragraph (c), must provide a
55.11 written termination notice at least 15 days before the effective date of the termination to the
55.12 client and the client's representative.

55.13 (d) An arranged home care provider terminating services under subdivision 7, paragraph
55.14 (b), must provide a written termination notice at least 30 days before the effective date of
55.15 the termination to the client and the client's representative.

55.16 (e) An arranged home care provider terminating services under subdivision 7, paragraph
55.17 (c), must provide a written termination notice at least 15 days before the effective date of
55.18 the termination to the client and the client's representative.

55.19 (f) If a resident moves out of a facility or cancels services received from the arranged
55.20 home care provider, nothing in this section prohibits the facility or arranged home care
55.21 provider from enforcing against the client any notice periods with which the client must
55.22 comply under the lease or the service agreement.

55.23 Subd. 9. **Contents of notice of termination.** (a) The notice required under subdivision
55.24 8 must contain, at a minimum:

55.25 (1) the effective date of the termination;

55.26 (2) a detailed explanation of the basis for the termination, including the clinical or other
55.27 supporting rationale;

55.28 (3) a detailed explanation of the conditions under which a new or amended lease or
55.29 service agreement may be executed;

55.30 (4) a statement that the resident has the right to appeal the termination by requesting a
55.31 hearing, and information concerning the time frame within which the request must be
55.32 submitted and the contact information for the agency to which the request must be submitted;

56.1 (5) a statement that the arranged home care provider, the facility, or both, as applicable,
56.2 must participate in a coordinated move as described in this section;

56.3 (6) the name and contact information of the person employed by the facility or the
56.4 arranged home care provider with whom the client may discuss the termination;

56.5 (7) information on how to contact the Office of Ombudsman for Long-Term Care to
56.6 request an advocate to assist regarding the termination;

56.7 (8) information on how to contact the Senior LinkAge Line under Minnesota Statutes,
56.8 section 256.975, subdivision 7, and an explanation that the Senior LinkAge Line may provide
56.9 information about other available housing or service options; and

56.10 (9) if the termination is only for services, a statement that the resident may remain in
56.11 the facility and may secure any necessary services from another provider of the resident's
56.12 choosing.

56.13 (b) An arranged home care provider, the facility, or both, as applicable, must provide
56.14 written notice of the client's termination of housing or services, respectively, in person or
56.15 by first-class mail. Service of the notice must be proved by affidavit of the person making
56.16 it.

56.17 (c) If sent by mail, the arranged home care provider, the facility, or both, as applicable,
56.18 must mail the notice to the client's last known address.

56.19 (d) An arranged home care provider, the facility, or both, as applicable, providing a
56.20 notice to the ombudsman of a client's termination of housing or services must provide the
56.21 ombudsman with a copy of the written notice that is provided to the client. The arranged
56.22 home care provider, the facility, or both, as applicable, must provide notice to the ombudsman
56.23 as soon as practicable, but in any event no later than two business days after notice is
56.24 provided to the client. The notice must include a telephone number for the client, or, if the
56.25 client does not have a telephone number, the telephone number of the client's representative
56.26 or case manager.

56.27 Subd. 10. **Right to appeal and permissible grounds to appeal termination.** (a) A
56.28 client has the right to appeal the termination of housing or services termination.

56.29 (b) A client may appeal a termination initiated under subdivisions 6 and 7 on the ground
56.30 that:

56.31 (1) there is a factual dispute as to whether the arranged home care provider, the facility,
56.32 or both, as applicable, had a permissible basis to initiate the termination;

(2) the termination would result in great harm or the potential for great harm to the client as determined by the totality of the circumstances, except in circumstances where there is a greater risk of harm to other clients or staff of the arranged home care provider, the facility, or both, as applicable;

(3) the client has corrected or demonstrated the ability to correct the reasons for the termination, or has identified a reasonable accommodation or modification, intervention, or alternative to the termination; or

(4) the arranged home care provider, the facility, or both, as applicable, has terminated housing, services, or both, in violation of state or federal law.

(c) Upon receipt of written notice of termination, a client has 30 calendar days to appeal the termination.

Subd. 11. **Appeal process.** (a) The Office of Administrative Hearings must conduct an expedited hearing no later than practicable under this section, but no later than 14 calendar days after the office receives the request, unless the parties agree otherwise or the chief administrative law judge deems the timing to be unreasonable, given the complexity of the issues presented.

(b) In a process to be determined by the commissioner, the client shall contact the commissioner to request an appeal of the termination within 30 days of written receipt of the termination notice, which will be timely scheduled with the Office of Administrative Hearings.

(c) The hearing must be held at the facility where the client lives, unless holding the hearing at that location is impractical, the parties agree to hold the hearing at a different location, or the chief administrative law judge grants a party's request to appear at another location or by remote means.

(d) The hearing is not a formal contested case proceeding, except when determined necessary by the chief administrative law judge. If the chief administrative law judge determines that the hearing shall proceed as a formal contested case proceeding, the hearing shall be held according to the Minnesota Revenue Recapture Act, Minnesota Rules, parts 1400.8505 to 1400.8612.

(e) The administrative law judge shall make a transcript of the hearing.

(f) The informal hearing will allow the client to provide an opportunity to present written or oral objections or defenses to the termination.

58.1 (g) If either party is represented by an attorney, the administrative law judge shall
58.2 emphasize the informality of the hearing.

58.3 (h) If the client is unable to represent themselves at the hearing, the resident may present
58.4 the client's appeal to the administrative law judge on the client's behalf.

58.5 (i) Parties may be, but are not required to be, represented by counsel. The appearance
58.6 of a party without counsel does not constitute the unauthorized practice of law.

58.7 (j) The arranged home care provider, the facility, or both, as applicable, bears the burden
58.8 of proof to establish by a preponderance of the evidence that the termination was permissible
58.9 if the appeal is brought on the ground listed in subdivision 12, paragraph (a), clause (4).

58.10 (k) The client bears the burden of proof to establish by a preponderance of the evidence
58.11 that the termination was permissible if the appeal is brought on the grounds listed in
58.12 subdivision 12, paragraph (b), clause (2) or (3).

58.13 (l) The hearing shall be limited to the amount of time necessary for the participants to
58.14 expeditiously present the facts about the proposed termination. The administrative law judge
58.15 shall issue a final decision as soon as practicable, but no later than ten business days after
58.16 the hearing.

58.17 (m) The administrative law judge's decision may contain any conditions that may be
58.18 placed on the client's continued residency or receipt of services, including but not limited
58.19 to changes to the service plan or a required increase in services.

58.20 (n) The client's termination must be rescinded if the client prevails in the appeal.

58.21 (o) The facility, arranged home care provider, or client may appeal the administrative
58.22 law judge's decision to the Minnesota Court of Appeals.

58.23 Subd. 12. **Service provision while appeal pending.** A termination of housing or services
58.24 shall not occur while an appeal is pending. If additional services are needed to meet the
58.25 health or safety needs of the client while an appeal is pending, the client is responsible for
58.26 contracting for those additional services from the facility or another home care provider
58.27 licensed under Minnesota Statutes, chapter 144A, and for ensuring the costs for those
58.28 additional services are covered.

58.29 Subd. 13. **Application of chapter 504B to appeals of terminations.** A client may not
58.30 bring an action under Minnesota Statutes, chapter 504B, to challenge a termination that has
58.31 occurred and been upheld under this section.

59.1 Subd. 14. **Restriction on lease nonrenewals.** If a facility decides to not renew a client's
59.2 lease, the facility must:

59.3 (1) provide the client with 60 calendar days' notice of the nonrenewal;

59.4 (2) ensure a coordinated move as provided under this section;

59.5 (3) consult and cooperate with the client; the client representative; the case manager of
59.6 a client who receives home and community-based waiver services under Minnesota Statutes,
59.7 section 256B.49, and chapter 256S; relevant health professionals; and any other person of
59.8 the client's choosing, to make arrangements to move the client; and

59.9 (4) prepare a written plan to prepare for the move.

59.10 Subd. 15. **Right to return.** If a client is absent from a facility for any reason, the facility
59.11 shall not refuse to allow a client to return if a lease termination has not been effectuated.

59.12 Subd. 16. **Coordinated moves.** (a) A facility or an arranged home care provider, as
59.13 applicable, must arrange a coordinated move for a client according to this subdivision if:

59.14 (1) a facility terminates a lease or closes the facility;

59.15 (2) an arranged home care provider terminates services; or

59.16 (3) an arranged home care provider reduces or eliminates services to the extent that the
59.17 client needs to move.

59.18 (b) If an event listed in paragraph (a) occurs, the arranged home care provider, together
59.19 with the facility must:

59.20 (1) ensure a coordinated move to a safe location that is appropriate for the client and
59.21 that is identified by the arranged home care provider;

59.22 (2) ensure a coordinated move to an appropriate service provider identified by the
59.23 arranged home care provider, provided services are still needed and desired by the client;
59.24 and

59.25 (3) consult and cooperate with the client; the client's representative; the case manager
59.26 for a client who receives home and community-based waiver services under Minnesota
59.27 Statutes, section 256B.49, and chapter 256S; relevant health professionals; and any other
59.28 person of the client's choosing, to make arrangements to move the client.

59.29 (c) The requirements in paragraph (b), clauses (1) and (2), may be satisfied by moving
59.30 the client to a different location within the same facility, if appropriate for the client.

60.1 (d) A client may decline to move to the location the facility identifies or to accept services
60.2 from a service provider the arranged home care provider identifies, and may choose instead
60.3 to move to a location of the client's choosing or to receive services from a service provider
60.4 of the client's choosing.

60.5 (e) Sixty days before the arranged home care provider reduces or eliminates one or more
60.6 services for a particular client, the arranged home care must provide written notice of the
60.7 reduction or elimination. If the facility, arranged home care provider, client, or client's
60.8 representative determines that the reduction or elimination of services will force the client
60.9 to move to a new location, the facility in coordination with the arranged home care provider
60.10 must ensure a coordinated move in accordance with this subdivision, and must provide
60.11 notice to the Office of Ombudsman for Long-Term Care.

60.12 (f) The facility or arranged home care provider, as applicable, must prepare a
60.13 client-relocation evaluation and client-relocation plan as described in this section to prepare
60.14 for the move to the new location or service provider.

60.15 (g) With the client's knowledge and consent, if the client is relocated to another facility
60.16 or to a nursing home, or if care is transferred to another service provider, the arranged home
60.17 care provider, the facility, or both, must timely convey to the new facility, nursing home,
60.18 or service provider:

60.19 (1) the client's full name, date of birth, and insurance information;

60.20 (2) the name, telephone number, and address of the client's representative, if any;

60.21 (3) the client's current, documented diagnoses that are relevant to the services being
60.22 provided;

60.23 (4) the client's known allergies that are relevant to the services being provided;

60.24 (5) the name and telephone number of the client's physician, if known, and the current
60.25 physician orders that are relevant to the services being provided;

60.26 (6) all medication administration records that are relevant to the services being provided;

60.27 (7) the most recent client assessment, if relevant to the services being provided; and

60.28 (8) copies of health care directives, "do not resuscitate" orders, and any guardianship
60.29 orders or powers of attorney.

60.30 Subd. 17. **Client-relocation evaluation.** If the client plans to move out of the facility
60.31 due to termination of housing or services, or nonrenewal of housing, the arranged home

61.1 care provider and the facility must work in coordination to prepare a written client-relocation
61.2 evaluation. The evaluation must include:

61.3 (a) the client's current service plan;

61.4 (b) a list of safe and appropriate housing and service providers that are in reasonable in
61.5 close proximity to the facility and are able to accept a new client; and

61.6 (c) the client's needs and choices.

61.7 Subd. 18. **Client-relocation plan.** (a) The arranged home care provider, in coordination
61.8 with the facility, must hold a planning conference to develop a relocation plan with the
61.9 client, the client's representative and case manager, if any, and other individuals invited by
61.10 the client.

61.11 (b) The client-relocation plan must accommodate the client-relocation evaluation
61.12 developed in subdivision 17.

61.13 (c) The client-relocation plan must include:

61.14 (1) the date and time that the client will move;

61.15 (2) how the client and the client's personal property, including pets, will be transported
61.16 to the new housing provider;

61.17 (3) how the facility will care for and store the client's belongings;

61.18 (4) recommendations to assist the client to adjust to the new living environment;

61.19 (5) recommendations for addressing the stress that a client with dementia may experience
61.20 when moving to a new living environment, if applicable;

61.21 (6) recommendations for ensuring the safe and proper transfer of the client's medications
61.22 and durable medical equipment;

61.23 (7) arrangements that have been made for the client's follow-up care and meals;

61.24 (8) a plan for transferring and reconnecting telephone and Internet services; and

61.25 (9) the party responsible for paying moving expenses and how the expenses will be paid.

61.26 (d) The facility and arranged home care provider must implement the relocation plan
61.27 and comply with the coordinated move requirements in this section.

61.28 Subd. 19. **Providing client-relocation information to new provider.** With the client's
61.29 consent, the arranged home care provider and the facility must provide the following
61.30 information in writing to the client's receiving facility or other service provider:

(1) the name and address of the facility and arranged home care provider, the dates of the client's admission and discharge, and the name and address of a person at the facility and arranged home care provider to contact for additional information;

(2) the client's most recent service plan, if the client has received services from the arranged home care provider; and

(3) the client's currently active "do not resuscitate" order and "physician order for life sustaining treatment," if any.

Subd. 20. **Client discharge summary.** At the time of discharge, the arranged home care provider in coordination with the facility, must provide the client, and, with the client's consent, the client's representative and case manager, if applicable, with a written discharge summary that includes:

(1) a summary of the client's stay that includes diagnoses, courses of illnesses, treatments, and therapies, and pertinent lab, radiology, and consultation results;

(2) a final summary of the client's status from the latest assessment or review under Minnesota Statutes, section 144A.4791, if applicable;

(3) reconciliation of all predischARGE medications with the client's postdischarge prescribed and over-the-counter medications; and

(4) postdischarge care plan that is developed with the client and, with the client's consent, the client's representative, which will help the client adjust to a new living environment. The postdischarge care plan must indicate where the client plans to reside, any arrangements that have been made for the client's follow-up care, and any post-discharge medical and non-medical services the client will need.

Subd. 21. **Services pending appeal.** If a client needs additional services during a pending termination appeal, the arranged home care provider must contact and inform the client's case manager, if applicable, of the client's responsibility to contract and ensure payment for those services.

Subd. 22. **Client assessment.** If an arranged home care provider seeks to terminate a client's services on the basis of subdivision 7, paragraph (c), clause (2), the provider must give the assessment that forms the basis of the termination to the client and include the name and contact information of any medical professionals who performed the assessment.

Subd. 23. **Appealing on behalf of client.** A client may appeal the termination directly or through an individual acting on the client's behalf.

63.1 Subd. 24. **No waiver.** No facility or arranged home care provider may request or require
63.2 that a client waive the client's rights or requirements under this section at any time or for
63.3 any reason, including as a condition of admission to the facility.

63.4 Subd. 25. **Assisted living bill of rights.** (a) Assisted living clients, as defined in
63.5 Minnesota Statutes, section 144G.01, subdivision 3, shall be provided with the home care
63.6 bill of rights in Minnesota Statutes, section 144A.44, except that for assisted living clients

63.23 **SERVICES AND SUPPORTS.**

63.24 \$467,000 in fiscal year 2021 is appropriated from the state government special revenue
