| 1.6 | Section 1. Minnesota Statutes 2018, section 484.841, subdivision 1, is amended to read: |
| 1.7 | Subdivision 1. Disposition of fines, fees, and other money; accounts. (a) Except as |
| 1.8 | otherwise provided within this subdivision, and except as otherwise provided by law, the |
| 1.9 | court administrator shall pay all fines and penalties collected by the court administrator, all |
| 1.10 | fees collected by the court administrator for court administrator's services, all sums forfeited |
| 1.11 | to the court as provided in this subdivision, and all other money received by the court |
| 1.12 | administrator to the subdivision of government entitled to it as follows on or before the 20th |
| 1.13 | day after the last day of the month in which the money was collected. Eighty percent of all |

(d) The court administrator may receive negotiable instruments in payment of fines, 2.5 penalties, fees or other obligations as conditional payments, and is not held accountable for 2.6 this until collection in cash is made and then only to the extent of the net collection after 2.7 deduction of the necessary expense of collection. 2.8

484.85 DISPOSITION OF FINES, FEES, AND OTHER MONEY; ACCOUNTS; 2.11 **RAMSEY COUNTY DISTRICT COURT.** 2.12

(a) In all cases prosecuted in Ramsey County District Court by an attorney for a 2.13 municipality or subdivision of government within Ramsey County for violation of a statute; 2.14 an ordinance; or a charter provision, rule, or regulation of a city; all fines, penalties, and 2.15 forfeitures collected by the court administrator shall be deposited in the state treasury and 2.16 2.17 distributed according to this paragraph. Except where a different disposition is provided by section 299D.03, subdivision 5, or other law, on or before the last day of each month, the 2.18 court shall pay over all fines, penalties, and forfeitures collected by the court administrator 2.19 during the previous month as follows: 2.20

(1) for offenses committed within the city of St. Paul, two-thirds paid to the treasurer 2.21 of the city of St. Paul and one-third eredited to the state general fund paid to the county 2.22 treasurer of the county in which the funds were collected who shall dispense them as provided 2.23 by law; and 2.24

(2) for offenses committed within any other municipality or subdivision of government 2.25 within Ramsey County, one-half paid to the treasurer of the municipality or subdivision of 2.26 government and one-half eredited to the state general fund paid to the county treasurer of 2.27 the county in which the funds were collected who shall dispense them as provided by law. 2.28

All other fines, penalties, and forfeitures collected by the district court shall be distributed 2.29 by the courts as provided by law. 2.30

(a) In all cases prosecuted in district court by an attorney for a 3.7 municipality or other subdivision of government within the county for violations of state 3.8 statute, or of an ordinance; or charter provision, rule, or regulation of a city; all fines, 3.9 penalties, and forfeitures collected shall be deposited in the state treasury and distributed 3.10 according to this paragraph. For the purpose of this section, the county attorney shall be 3.11 considered the attorney for any town in which a violation occurs. Except where a different 3.12 disposition is provided by section 299D.03, subdivision 5, 484.841, 484.85, or other law, 3.13 on or before the last day of each month, the courts shall pay over all fines, penalties, and 3.14 forfeitures collected by the court administrator during the previous month as follows: 3.15

3.16 (1) 100 percent of all fines or penalties for parking violations for which complaints and
