- (c) In awarding grants under this section, the commissioner must prioritize grant awards to community-based organizations experienced in providing support and services to victims and families who experienced trauma resulting from government-sponsored activities.
- Subd. 3. **Evaluation.** Grant recipients must provide the commissioner with information required by the commissioner to evaluate the grant program, in a time and manner specified by the commissioner.
 - Subd. 4. Reports. The commissioner must submit a status report by January 15, 2023, and an additional report by January 15, 2024, on the operation and results of the grant program, to the extent available. These reports must be submitted to the chairs and ranking minority members of the legislative committees with jurisdiction over health care. The report due January 15, 2023, must include information on grant program activities to date and an assessment of the need to continue to offer services provided by grant recipients to victims, families, and heirs who experienced trauma resulting from government-sponsored activities. The report due January 15, 2024, must include a summary of the services offered by grant recipients; an assessment of the need to continue to offer services provided by grant recipients to victims, families, and heirs who experienced trauma resulting from government-sponsored activities; and an evaluation of the grant program's goals and outcomes.

Sec. 2. <u>APPROPRIATION</u>; <u>EMMETT LOUIS TILL VICTIMS RECOVERY</u> PROGRAM.

\$500,000 in fiscal year 2024 is appropriated from the general fund to the commissioner
of health for the Emmett Louis Till Victims Recovery Program. This is a onetime
appropriation and is available until June 30, 2025.
