Subdivision 1. Agreement. All apprentices shall be employed under an apprentice agreement between the sponsoring salon and the apprentice and approved by the Department of Labor and Industry under section 178.07. All apprenticeships are governed by the requirements of chapter 178, the minimum standards of apprenticeship under Minnesota Rules, part 5200.0320, and the requirements of this chapter and any rules adopted by the board.

Subd. 2. Training requirements. Apprentices shall receive from a licensed salon at least 3,180 hours of practical training and at least 288 training hours of theoretical instruction in order to complete the apprenticeship program and be eligible to take the examination for a cosmetologist license. Apprentices shall receive training for a total of at least 32 hours per week. The training shall be completed in not less than two years and not more than four years.

Subd. 3. Practice. (a) No apprentice under this section may practice cosmetology except under the supervision of a licensed cosmetology manager, whose cosmetology license is not an inactive license, or under the supervision of a licensed cosmetologist, whose cosmetologist license is not an inactive license, and to whom supervisory authority has been delegated by a licensed cosmetology manager. A licensed cosmetology manager may only delegate supervisory authority to a licensed cosmetologist who has completed at least 2,000 hours of practice as a licensed cosmetologist. A supervising cosmetology manager must have had a valid license for a minimum of three consecutive years. A supervising cosmetology instructor must have had a valid license for a minimum of one year.

(b) Apprentices shall be trained in all branches of practical work and in all subjects required to be taught in schools of cosmetology as prescribed by the examining board by rule.
