BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. MALL OF AMERICA LIGHT RAIL STATION IMPROVEMENTS.

Subdivision 1. **Appropriation.** \$15,000,000 is appropriated from the bond proceeds

1.7

fund to the Metropolitan Council for design and construction of improvements to the Mall

1.8

of America Station on the Hiawatha Corridor light rail transit line. The Metropolitan

Council must consult with the city of Bloomington throughout the design and construction

process.

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the

1.12

bond proceeds fund, the commissioner of management and budget shall sell and issue

1.13

bonds of the state in an amount up to \$15,000,000 in the manner, upon the terms, and with

the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the

Minnesota Constitution, article XI, sections 4 to 7.
