- (e) (f) "Shared home care nursing" means the provision of home care nursing services by a home care nurse to two recipients at the same time and in the same setting.
- Sec. 2. Minnesota Statutes 2016, section 256B.0654, is amended by adding a subdivision to read:
  - Subd. 5. Home care nursing services rate adjustments. (a) Effective for services provided after June 30, 2017, payments for complex pediatric home care nursing services are set at a level 25 percent higher than the payment rate for complex home care nursing services in effect on July 1, 2015. This increase does not apply to federally qualified health centers, rural health centers, and Indian health services. The commissioner shall adjust payment rates to managed care and county-based purchasing plans to reflect this increase, and shall require plans to pass on the full amount of the rate increase to eligible home care nursing agencies, in the form of higher payments for home care nursing services.
  - (b) Home care nursing agencies that receive a rate increase under this subdivision must use ten percent of the additional revenue to pay for complex pediatric home care training of nursing staff and 80 percent of the additional revenue to increase pay and benefits for home care nurses.
