2.14	communities, civic organizations, veterans service organizations, and individuals.
2.15	(b) For determining the veterans cemetery site in southeastern Minnesota, the
2.16	commissioner shall give priority consideration to land owned and proposed for donation
2.17	by the county of Fillmore.
2.18	(c) The commissioner's planning process for a state veterans cemetery must include,
2.19	at a minimum, the following actions:
2.20	(1) determining the need for the cemetery;
2.21	(2) investigating the availability of suitable land for the cemetery;
2.22	(3) assessment of impacts of the cemetery;
2.23	(4) encouragement of support from veteran service organizations and local
2.24	governments; and
2.25	(5) preparation and submission of a preapplication for a grant from the United States
2.26	Department of Veterans Affairs for commitment of funding for establishing the cemetery.
