1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. DIRECTION TO COMMISSIONER OF HUMAN SERVICES; TEFRA
1.7	<b>OPTION IMPROVEMENT MEASURES.</b>
1.8	(a) The commissioner of human services, in consultation with the Minnesota Eligibility
1.9	System Executive Steering Committee, shall, using existing appropriations, develop content
1.10	to be included on the MNsure website explaining the TEFRA option under medical assistance
1.11	for applicants who indicate during the online application process that a child in the family
1.12	has a disability. The online content shall include a notification informing applicants that
1.13	the child with a disability may be eligible for medical assistance under the TEFRA option
1.14	even if the applicant does not qualify for medical assistance based on income. The notification
1.15	shall be displayed when the applicant is informed that the applicant is ineligible for medical
1.16	assistance based on the applicant's income.
1.17	(b) The commissioner shall develop a cover letter explaining the TEFRA option under
1.18	medical assistance, as well as the application and renewal process, to be disseminated with
1.19	the DHS-6696A form to applicants who may qualify for medical assistance under the TEFRA
1.20	option. The commissioner shall provide the content and the form to the executive director
1.21	of MNsure for inclusion on the MNsure website.
1.22	(c) The commissioner shall convene a stakeholder group that shall consider improvements
1.23	to the TEFRA option enrollment and renewal processes, including but not limited to:
