Subd. 5. Termination of taxes. (a) The taxes imposed under subdivisions 1 and 2 expire 3.14 at the later of (1) December 31, 2009, or (2) when the city council determines that sufficient 3.15 3.16 funds have been received from the taxes to finance the first \$71,500,000 of capital expenditures and bonds for the projects authorized in subdivision 3, including the amount 3.17 to prepay or retire at maturity the principal, interest, and premium due on any bonds issued 3.18 for the projects under subdivision 4, unless the taxes are extended as allowed in paragraph 3.19 (b). Any funds remaining after completion of the project and retirement or redemption of 3.20 the bonds shall also be used to fund the projects under subdivision 3. The taxes imposed 3.21 under subdivisions 1 and 2 may expire at an earlier time if the city so determines by 3.22 ordinance. 3.23

(b) Notwithstanding Minnesota Statutes, sections 297A.99 and 477A.016, or any other 3.24 contrary provision of law, ordinance, or city charter, the city of Rochester may, by ordinance, 3.25 extend the taxes authorized in subdivisions 1 and 2 beyond December 31, 2009, if approved 3.26 by the voters of the city at a special election in 2005 or the general election in 2006. The 3.27 question put to the voters must indicate that an affirmative vote would allow up to an 3.28 additional \$40,000,000 of sales tax revenues be raised and up to \$40,000,000 of bonds to 3.29 be issued above the amount authorized in the June 23, 1998, referendum for the projects 3.30 specified in subdivision 3. If the taxes authorized in subdivisions 1 and 2 are extended under 3.31 this paragraph, the taxes expire when the city council determines that sufficient funds have 3.32 been received from the taxes to finance the projects and to prepay or retire at maturity the 3.33 principal, interest, and premium due on any bonds issued for the projects under subdivision 3.34

4.1 4. Any funds remaining after completion of the project and retirement or redemption of the4.2 bonds may be placed in the general fund of the city.

(c) Notwithstanding Minnesota Statutes, sections 297A.99 and 477A.016, or any other 4.3 contrary provision of law, ordinance, or city charter, the city of Rochester may, by ordinance, 4.4 extend the taxes authorized in subdivisions 1, paragraph (a), and 2, up to December 31, 4.5 2049, provided that all additional revenues above those necessary to fund the projects and 4.6 associated financing costs listed in subdivision 3, paragraphs (a) to (e), are committed to 4.7 fund public infrastructure projects contained in the development plan adopted under 4.8 Minnesota Statutes, section 469.43, including all financing costs; otherwise the taxes 4.9 terminate when the city council determines that sufficient funds have been received from 4.10 the taxes to finance expenditures and bonds for the projects authorized in subdivision 3, 4.11 paragraphs (a) to (e), plus an amount equal to the costs of issuance of the bonds and including 4.12 the amount to prepay or retire at maturity the principal, interest, and premiums due on any 4.13 bonds issued for the projects under subdivision 4. 4.14

4.15 (d) The tax imposed under subdivision 1, paragraph (b), expires at the earlier of <u>December</u>
4.16 <u>31,</u> 2049, or when the city council determines that sufficient funds have been raised from
4.17 the tax plus all other city funding sources authorized in this article to meet the city obligation
4.18 for financing the public infrastructure projects contained in the development plan adopted
4.19 under Minnesota Statutes, section 469.43, including all financing costs.

(e) The tax imposed under subdivision 1a expires at the earlier of (1) 24 years after first 4.20 imposed, or (2) when the city council determines that the amount of revenues received from 4.21 the tax is sufficient to pay for the project costs authorized under subdivision 3a for projects 4.22 approved by the voters as required under Minnesota Statutes, section 297A.99, subdivision 4.23 3, paragraph (a), plus an amount sufficient to pay the costs related to issuance of the bonds 4.24 under subdivision 4a, including interest on the bonds. Except as otherwise provided in 4.25 Minnesota Statutes, section 297A.99, subdivision 3, paragraph (f), any funds remaining 4.26 after payment of the allowed costs due to the timing of the termination of the tax under 4.27 Minnesota Statutes, section 297A.99, subdivision 12, shall be placed in the general fund of 4.28 the city. The tax imposed under subdivision 1a may expire at an earlier time if the city so 4.29 determines by ordinance. 4.30
