- Section 1. Minnesota Statutes 2018, section 160.02, subdivision 1a, is amended to read:
- Subd. 1a. **Bikeway.** "Bikeway" means a bicycle lane, bicycle path, shared use path,

 bicycle route, or similar bicycle facility, regardless of whether designed for the exclusive

 use of bicycles or for shared use with other transportation modes has the meaning given in

 section 169.011, subdivision 9.
- 1.11 Sec. 2. Minnesota Statutes 2018, section 169.011, subdivision 5, is amended to read:
- Subd. 5. **Bicycle lane.** "Bicycle lane" means a portion of a roadway or shoulder designed for exclusive or preferential use by persons using bicycles. Bicycle lanes are to be distinguished from the portion of the roadway or shoulder used for motor vehicle traffic by physical barrier, striping, marking, or other similar device.

- Subd. 4. **Riding rules.** (a) Every person operating a bicycle upon a roadway shall <u>on a road must</u> ride as close as practicable to the right-hand curb or edge of the roadway except under any of the following situations <u>road as the bicycle operator determines is safe. A person operating a bicycle is not required to ride as close to the right-hand curb or edge when:</u>
 - (1) when overtaking and passing another vehicle proceeding in the same direction;
 - (2) when preparing for a left turn at an intersection or into a private road or driveway;
- (3) when reasonably necessary to avoid conditions that make it unsafe to continue along the right-hand curb or edge, including fixed or moving objects, vehicles, pedestrians, animals, surface hazards, or narrow width lanes, that make it unsafe to continue along the right-hand curb or edge; or;
 - (4) when operating on the shoulder of a roadway or in a bicycle lane-; or
- (5) operating in a right-hand turn lane before entering an intersection.
- (b) If a bicycle is traveling on a shoulder of a roadway, the bicycle shall operator must travel in the same direction as adjacent vehicular traffic.
- (c) Persons riding bicycles upon a roadway or shoulder shall <u>must</u> not ride more than two abreast and shall <u>must</u> not impede the normal and reasonable movement of traffic and, on a laned roadway, shall ride within a single lane.
- (d) A person operating a bicycle upon a sidewalk, or across a roadway or shoulder on a crosswalk, shall must yield the right-of-way to any pedestrian and shall give an audible signal when necessary before overtaking and passing any pedestrian. No A person shall must not ride a bicycle upon a sidewalk within a business district unless permitted by local authorities. Local authorities may prohibit the operation of bicycles on any sidewalk or crosswalk under their jurisdiction.
- (e) An individual operating a bicycle or other vehicle on a bikeway shall <u>must</u> leave a safe distance when overtaking a bicycle or individual proceeding in the same direction on the bikeway, and shall maintain clearance until safely past the overtaken bicycle or individual.
- (f) A person lawfully operating a bicycle on a sidewalk, or across a roadway or shoulder on a crosswalk, shall have all the rights and duties applicable to a pedestrian under the same circumstances.

(g) (f) A person may operate an electric-assisted bicycle on the shoulder of a roadway,
on a bikeway, or on a bicycle trail if not otherwise prohibited under section 85.015,
subdivision 1d; 85.018, subdivision 2, paragraph (d); or 160.263, subdivision 2, paragraph
(b), as applicable.
(g) Notwithstanding section 169.06, subdivision 4, a bicycle operator may cross an
intersection proceeding from a dedicated right-hand turn lane without turning right.
