REPORT ON A TRANSITIONAL BENEFIT DEMONSTRATION 1.5 PROJECT. 1.6 (a) By January 15, 2024, the commissioner of human services shall report to the chairs 1.7 and ranking minority members of the legislative committees with jurisdiction over health 1.8 and human services policy and finance on the feasibility of a demonstration project that 1.9 continues to offer human services program benefits to individuals no longer eligible for 1.10 those programs during a transition period to reduce benefit cliffs and incentivize those 1.11 individuals to take advantage of career advancement opportunities. - (4) the changes to program benefits, premiums, and cost-sharing for former and current program enrollees necessary to ensure that the demonstration project is budget neutral;

 - (6) evaluation criteria and an evaluation process for the demonstration project.
