1.8	Subd. 9. Data derived from driver's license applications. Data on an application
1.9	for a driver's license, a Minnesota identification card, or a learner's permit transferred to
1.10	the secretary of state that are provided by a person whom the secretary of state determines
1.11	is not eligible to vote are governed by section 201.161.

1.16	Subdivision 1. Automatic registration. An individual who properly completes
1.17	an application for a new or renewed Minnesota driver's license, instruction permit, or

1.19	vote as provided in this section, unless the applicant declines to be registered.
1.20	Subd. 2. Applications. The Department commissioner of public safety, in
1.21	consultation with the secretary of state, shall change its the applications for an original,
1.22	duplicate, or change of address driver's license, instruction permit, or identification card so
1.23	that the forms may also serve as voter registration applications. The forms must contain

spaces for all information collected by voter registration applications prescribed by the 2.1 secretary of state and a box for the applicant to decline to be registered to vote.
