1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2016, section 93.001, is amended to read:
1.8	93.001 POLICY FOR MINERAL DEVELOPMENT.
1.9	(a) It is the policy of the state to provide for the diversification of the state's mineral
1.10	economy through long-term support of mineral exploration, evaluation, environmental
1.11	protection, research, development, production, and commercialization. The commissioner
1.12	of natural resources is responsible for mineral evaluation and environmental protection.
1.13	The commissioner of employment and economic development is responsible for supporting
1.14	appropriate mineral research, exploration, development, production, and commercialization.
1.15	(b) The commissioner of natural resources must ensure that mining is conducted with
1.16	sound natural resource conservation and management principles that protect the environment
1.17	for future generations.
1.18	Sec. 2. Minnesota Statutes 2016, section 93.0015, subdivision 1, is amended to read:
1.19	Subdivision 1. Establishment; membership. The Mineral Coordinating Committee is
1.20	established to plan for diversified and environmentally sound mineral development. The

3.8 (a) Except as otherwise expressly provided by law, leases for iron ore or other minerals
3.9 belonging to the state shall be issued only upon public sale as provided under this section.

3.10 (b) The sale of leases shall be held at such times and places as designated by the3.11 commissioner.

3.12 (c) The commissioner shall give public notice of intent to hold a public sale by publication
3.13 in the State Register, the EQB Monitor, and such other publications as the commissioner
3.14 may direct at least 90 days prior to the proposed date of sale.

3.15 (d) The commissioner shall give public notice of each sale by publication for three successive weeks in a newspaper that has its known office of issue in the county seat of the 3.16 county in which the mining units to be leased are located and in a daily newspaper printed 3.17 and published in Hibbing and Virginia. If no newspaper has its known office of issue in the 3.18 county seat of a particular county, the commissioner shall publish notice in the newspaper 3.19 designated as the publisher of the official proceedings of the county board of that county. 3.20 The first publication shall be at least 30 days before the date of sale. The public notice of 3.21 sale shall also be published in the State Register and the EQB Monitor at least 30 days 3.22 before the date of sale and may be published in additional newspapers and trade magazines, 3.23 as the commissioner may direct. 3.24

- 3.27 (2) the place or places where the list of mining units to be offered for sale will be available
 3.28 for inspection and where forms for bids and applications for leases may be obtained; and

4.13 (a) The minerals management account is created as an account in the natural resources
4.14 fund. Interest earned on money in the account accrues to the account. Money in the account
4.15 may be spent or distributed only as provided in paragraphs (b) and (c).

(b) If the balance in the minerals management account exceeds \$3,000,000 on March
31, June 30, September 30, or December 31, the amount exceeding \$3,000,000 must be
distributed to the permanent school fund, the permanent university fund, and taxing districts
as provided in section 93.22, subdivision 1, paragraph (c). The amount distributed to each
fund must be in the same proportion as the total mineral lease revenue received in the
previous biennium from school trust lands, university lands, and lands held by the state in
trust for taxing districts.

<u>development</u>, be included in the unit by inserting a description of the ore in the designation
of the unit. Otherwise the ore shall not be considered as included in the unit. Upon the
inclusion of the ore in the unit, it shall be subject to all provisions of law relating to the sale,
issuance, terms, and conditions of a lease covering the unit and other matters pertaining
thereto, so far as applicable.

5.10 the ground, such designation to be made according to section 93.15, so far as applicable.

(b) The commissioner <u>of natural resources</u> may lease the mining unit at public or private
sale for an amount and under terms and conditions prescribed by the commissioner <u>of natural</u>
<u>resources</u>. The lease term may not exceed 25 years. The amount payable for stockpiled iron
ore material shall be at least equivalent to the minimum royalty that would be payable under
section 93.20.

5.17 93.44 DECLARATION OF POLICY.

In recognition of the effects of mining upon the environment, it is hereby declared to be 5.18 the policy of this state to provide for the reclamation of certain lands hereafter subjected to 5.19 the mining of metallic minerals or peat where such reclamation is necessary, both in the 5.20 interest of the general welfare and as an exercise of the police power of the state, to control 5.21 possible adverse environmental effects of mining, to preserve the natural resources, and to 5.22 encourage the planning of future land utilization, while at the same time promoting the 5.23 orderly development of mining, and the encouragement of good mining practices, and the 5.24 recognition and identification of the beneficial aspects of mining. 5.25
