A bill for an act relating to health occupations; establishing licensure for medical laboratory science professionals; creating the Board of Medical Laboratory Science; establishing fees; proposing coding for new law as Minnesota Statutes, chapter 148F. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: Section 1. [148F.01] DEFINITIONS. Subdivision 1. Applicability. For purposes of this chapter, the following terms have the meanings given them. Subd. 2. Accredited medical laboratory educational program. "Accredited medical laboratory educational program" means a program to provide instruction and experience in medical laboratory science that has been accredited by an accrediting agency recognized by the United States Department of Health and Human Services. Subd. 3. Categorical medical laboratory scientist. "Categorical medical laboratory scientist" means an individual eligible for licensure under this chapter who performs the functions of a medical laboratory scientist in one or more of the following areas of the laboratory depending upon the certification examinations passed: chemistry, hematology, immunohematology, and microbiology. Subd. 4. CLIA. "CLIA" means Clinical Laboratory Improvement Amendments of 1988 and includes Public Law 10-578 and Code of Federal Regulations, title 42, section 493. CLIA regulations provide a minimum foundation upon which personnel standards for entry level technical personnel in this state are built. Qualifications and responsibilities for laboratory director, technical supervisor, and technical consultant are as specified in CLIA regulations. All medical laboratory personnel are under the supervision, control, and responsibility of the laboratory director.

2.1	Subd. 5. Commissioner. "Commissioner" means the commissioner of health or the
2.2	commissioner's designee.
2.3	Subd. 6. Cytotechnologist. "Cytotechnologist" means an individual who
2.4	specializes in the cellular analysis of patient samples from all body sites, for the purpose
2.5	of evaluating, detecting, and providing diagnostic and prognostic information regarding
2.6	disease processes, including those that require the exercise of independent technical
2.7	judgment, and who:
2.8	(1) assists health care providers with the collection, detection, and interpretation
2.9	of normal and abnormal cells, infectious agents, and other noncellular material from
2.10	submitted specimens;
2.11	(2) performs a variety of medical laboratory tests to ascertain information to
2.12	help in classification, prognosis, or disease detection, including, but not limited to,
2.13	immunohistochemical and molecular techniques;
2.14	(3) establishes and implements protocols, quality control, method selection,
2.15	equipment selection and maintenance, and activities related to the preanalytic, analytic,
2.16	and postanalytic phases of testing; and
2.17	(4) may direct, supervise, consult, and educate and perform research functions.
2.18	Subd. 7. Histotechnician. "Histotechnician" means an individual who:
2.19	(1) prepares tissue specimens for microscopic examination;
2.20	(2) monitors, performs, selects, develops, evaluates, correlates, and ensures accuracy
2.21	and validity of laboratory testing and procedures including, but not limited to, techniques
2.22	in fixation, processing, embedding, microtomy, cryotomy, ultramicrotomy, and staining;
2.23	(3) prepares gross specimens as defined by and under the direction of a
2.24	board-certified pathologist;
2.25	(4) establishes and implements protocols, quality assurance, and quality control
2.26	related to the following procedures: histochemical, immunohistochemical, electron
2.27	microscopy, cytopreparation, in situ hybridization, enzyme histochemical, DNA
2.28	hydrolysis, laser capturing, molecular techniques, and research; and
2.29	(5) participates in method selection, development, equipment selection and

2.32	Subd. 8. Histotechnologist. "Histotechnologist" means an individual who:
2.33	(1) prepares tissue specimens for microscopic examination;
2.34	(2) monitors, performs, selects, develops, evaluates, correlates, and ensures accuracy
2.35	and validity of laboratory testing and procedures including, but not limited to, techniques
2.36	in fixation, processing, embedding, microtomy, cryotomy, ultramicrotomy, and staining;

3.1	(3) prepares gross specimens as defined by and under the direction of a
3.2	board-certified anatomic pathologist;
3.3	(4) establishes and implements protocols, quality assurance, and quality control
3.4	related to the following procedures: histochemical, immunohistochemical, electron
3.5	microscopy, cytopreparation, in situ hybridization, enzyme histochemical, DNA
3.6	hydrolysis, laser capturing, molecular techniques, and research;
3.7	(5) establishes and implements new protocols and procedures dealing directly in
3.8	quality assessment, method development, and equipment selection and maintenance and
3.9	all activities related to preanalytical and analytical phases of tissue preparation; and
3.10	(6) may direct, supervise, consult, educate, and perform research functions.
3.11	Subd. 9. Independent medical judgment. In the laboratory, "independent medical
3.12	judgment" is exercised only by a pathologist or other licensed physician in the diagnosis
3.13	and treatment decisions related to clinical laboratory tests.
3.14	Subd. 10. Independent technical judgment. "Independent technical judgment"
3.15	means the performance or conduct of clinical laboratory tests and assumption of
3.16	responsibility for determination of the validity of clinical laboratory test results without
3.17	intervention by or under the supervision of another health care provider authorized by
3.18	law to assume responsibility for the conduct and validity of clinical laboratory tests.
3.19	The authorized exercise of independent technical judgment does not include or permit
3.20	the independent medical judgment in the diagnosis, treatment, or reporting of clinical
3.21	laboratory results or their interpretation to patients, except as authorized by a laboratory
3.22	director and according to CLIA.
3.23	Subd. 11. Medical laboratory or laboratory. "Medical laboratory" or "laboratory"
3.24	means any facility or office in Minnesota in which medical laboratory tests are performed.
3.25	Subd. 12. Medical laboratory scientist or generalist. "Medical laboratory
3.26	scientist" or "generalist" means an individual eligible for licensure under this chapter who:
3.27	(1) performs medical laboratory tests, including tests that require the exercise of
3.28	independent technical judgment;
3.29	(2) establishes and implements protocols, quality assessment, method development
3.30	and selection, equipment selection and maintenance, and all activities related to the
3.31	preanalytic, analytic, and postanalytic phases of laboratory testing; and
3.32	(3) may direct, supervise, consult, educate, and perform research functions.
3.33	Subd. 13. Medical laboratory specialist. "Medical laboratory specialist" means an
3.34	individual certified and eligible for licensure in one of the categories in subdivisions 14 to
3.35	16 to perform testing including the tests that require the exercise of independent technical
3.36	judgment needed to establish and implement protocols, quality assessment, method

1.2	to the preanalytic, analytic, and postanalytic phases of laboratory testing, and who direct,
1.3	supervise, consult, and educate in a specific specialized section of the laboratory.
1.4	Subd. 14. Medical laboratory specialist in cytogenetics. "Medical laboratory
1.5	specialist in cytogenetics" means an individual eligible for licensure under this chapter to
1.6	perform standard cytogenetic and molecular testing procedures used to evaluate possible
1.7	genetic anomalies.
1.8	Subd. 15. Medical laboratory specialist in molecular biology/pathology.
1.9	"Medical laboratory specialist in molecular biology/pathology" means an individual
1.10	eligible for licensure under this chapter to perform all aspects of molecular analysis
1.11	including, but not limited to, recombinant DNA technology, polymerase chain reaction,
1.12	and hybridization techniques.
1.13	Subd. 16. Medical laboratory specialist in histocompatibility. "Medical
1.14	laboratory specialist in histocompatibility" means an individual eligible for licensure
1.15	under this chapter to perform histocompatibility testing procedures including, but not
1.16	limited to, molecular and serological techniques.
1.17	Subd. 17. Medical laboratory technician. "Medical laboratory technician" means
1.18	an individual eligible for licensure under this chapter who performs medical laboratory
1.19	tests at all CLIA complexity levels according to established and approved protocols and
1.20	requiring limited exercise of independent judgment.
1.21	Subd. 18. Medical laboratory test or laboratory test. "Medical laboratory
1.22	test" or "laboratory test" means a microbiological, serological, chemical, biological,
1.23	hematological, immunological, immunohematological, radiobioassay, cytological,
1.24	histological preparation, molecular, biophysical, or any other test or procedure performed
1.25	on material derived from or existing in a human body, which provides information for
1.26	the diagnosis, prevention, or monitoring of a disease or impairment or assessment of a
1.27	medical condition. A medical laboratory test includes components of the preanalytic and
1.28	postanalytic phases of testing, as well as the analytic phase, which occurs in the laboratory.
1.29	Subd. 19. Medical laboratory subspecialists. "Medical laboratory subspecialists"
1.30	means an individual eligible for licensure under this chapter to perform the functions
1.31	of a medical laboratory scientist in a subspecialty or esoteric clinical laboratory that is
1.32	not one of the general categorical areas of the laboratory. The subspecialty/esoteric
1.33	laboratories may be disease or medical specialty-oriented or utilize advanced technology
1.34	not routinely used in the clinical laboratory. These subspecialty/esoteric laboratories may
1.35	be subspecialized areas within the hematology, chemistry, immunology, transfusion,
1.36	medicine, genetics, or microbiology disciplines.

5.1	Subd. 20. Nationally recognized certification agency. "Nationally recognized
5.2	certification agency" means an agency that provides certification examinations for medical
5.3	laboratory professionals. As the agency defines new certification examinations, the
5.4	commissioner and the advisory council will recognize these examinations.
5.5	Subd. 21. Pathologist's assistant. "Pathologist's assistant" means an individual
5.6	specializing in prediagnostic surgical pathology and autopsy pathology who assists
5.7	pathologists.
5.8	Subd. 22. Phlebotomist. "Phlebotomist" means an individual who is qualified to
5.9	obtain blood samples for testing by means of venipuncture, capillary puncture, or access
5.10	of venous access devices, to perform specimen processing and preparation of samples for
5.11	testing, and to perform waived and point-of-care testing.
5.12	Subd. 23. Point-of-care testing. "Point-of-care testing" means analytical patient
5.13	testing activities provided within a facility, which do not require permanent dedicated
5.14	space including, but not limited to, analytic instruments that are temporarily brought to a
5.15	patient care location. Point-of-care testing must be under the direction of an individual
5.16	licensed under this chapter at the baccalaureate degree level or who qualifies as a
5.17	laboratory director under federal CLIA regulations.
5.18	Subd. 24. Trainee/student. "Trainee/student" means an individual who has
5.19	not fulfilled the educational requirements to take an approved nationally recognized
5.20	certification examination or who needs to obtain full-time comprehensive experience
5.21	under supervision.
5.22	Subd. 25. Waived test. "Waived test" means a laboratory examination or procedure
5.23	as determined by the United States Food and Drug Administration which has an
5.24	insignificant risk of an erroneous result, including those which:
5.25	(1) have been approved by the United States Food and Drug Administration for
5.26	home use;
5.27	(2) employ methodologies that are so simple and accurate as to render the likelihood
5.28	of erroneous results negligible; or
5.29	(3) pose no reasonable risk of harm to the patient if performed incorrectly.
5.30	Sec. 2. [148F.02] EXCEPTIONS.
5.31	(a) This chapter does not apply to:
5.32	(1) the qualifications for laboratory directors, technical supervisors, or technical
5.33	consultants as established by federal CLIA;
5.34	(2) other licensed or registered professionals performing functions within the
5.35	professional's scope of practice;

6.1	(3) medical laboratory science professionals employed by the United States
6.2	government, or any bureau, division, or agency, while performing duties within the scope
6.3	of the professional's federal employment;
6.4	(4) medical laboratory science professionals engaged exclusively in basic science or
6.5	investigative research, provided that the results of any examination performed are not used
6.6	in health maintenance, diagnosis, or treatment of disease as described in federal CLIA
6.7	regulations under Code of Federal Regulations, title 42, section 493;
6.8	(5) professionals engaged exclusively in assay development or management-related
6.9	activities in the clinical laboratory, provided the results of any examination performed
6.10	are not used in health maintenance, diagnosis, or treatment of disease as described in
6.11	federal CLIA regulations;
6.12	(6) professionals engaged exclusively in the education of medical laboratory science
6.13	professionals, provided that results of any examination performed are not used in health
6.14	maintenance, diagnosis, or treatment of disease as described in federal CLIA regulations;
6.15	(7) professionals engaged exclusively in providing phlebotomy services;
6.16	(8) pathologist's assistants or individuals performing pathology assistant activities
6.17	under supervision by pathologists;
6.18	(9) cytotechnologists, which fall under the federally mandated CLIA personnel
6.19	certification requirements;
6.20	(10) histotechnicians and histotechnologists;
6.21	(11) students or trainees enrolled in a medical laboratory science education program
6.22	provided that:
6.23	(i) the activities performed by the student or trainee constitute a part of a planned
6.24	course in the program;
6.25	(ii) the student or trainee is clearly designated as intern, trainee, or student; and
6.26	(iii) the student or trainee is working directly under an individual licensed under
6.27	this chapter to practice medical laboratory science or by a professional who is exempt
6.28	under this section;
6.29	(12) individuals who only perform waived tests or moderately complex point-of-care
6.30	tests under the direction of a qualified CLIA laboratory director according to federal
6.31	CLIA regulations; and
6.32	(13) individuals who perform moderately complex testing as defined by federal
6.33	CLIA regulations provided that the laboratory complies with the following requirements:
6.34	(i) within the laboratory, a licensed medical laboratory scientist or individual who
6.35	qualifies as a laboratory director under federal CLIA regulations is responsible for:

7.1	(A) designing, providing, and supervising the training programs for the testing
7.2	personnel;
7.3	(B) supervising and monitoring the quality assurance and quality control activities
7.4	of the testing site;
7.5	(C) assisting in the selection of technology;
7.6	(D) reviewing the results of proficiency testing and recommending corrective
7.7	action, if necessary; and
7.8	(E) monitoring the continued laboratory testing competency of the testing personnel;
7.9	(ii) documented personnel evaluation processes are in place, which ensure and
7.10	document the continued competency of the testing personnel; and
7.11	(iii) after the effective date of this chapter, the licensed medical laboratory scientist
7.12	or individual who qualifies as a laboratory director under CLIA regulations must ensure

7.19	requirements of this chapter and requires the individual to be licensed as required in
7.20	this chapter.
7.21	(b) This chapter does not apply to a declared emergency as defined in section 12.03,
7.22	that reduces laboratory capacity or increases testing demands, or other loss of critical
7.23	laboratory capacity. Practitioners who are not licensed in any state, but are certified by one
7.24	of the agencies recognized in this chapter or deemed competent by the affected laboratory
7.25	director may practice as needed in the emergency situation.
7.26	Sec. 3. [148F.03] LICENSURE REQUIRED; TITLES USED, RESTRICTED,
7.27	AND ALLOWED.
7.28	Subdivision 1. Unlicensed practice prohibited. Effective January 1, 2013, no
7.29	individual shall perform a medical laboratory test unless the individual is licensed under
7.30	this chapter as a medical laboratory scientist, categorical medical laboratory scientist,
7.31	medical laboratory technician, medical laboratory specialist in cytogenetics, medical
7.32	laboratory specialist in molecular biology/pathology, or medical laboratory specialist in
7.33	histocompatability, medical laboratory subspecialist, or is exempt from licensure under
7.34	section 148F.02.

8.1	Subd. 2. Protected titles and restrictions on use. No individual shall use the phrase
8.2	medical laboratory scientist, categorical medical laboratory scientist, medical laboratory

8.15	tests and provide test results to physicians and patients upon request or upon physician
8.16	referral according to CLIA. The practice of medical laboratory science includes:
8.17	(1) the production of test data;
8.18	(2) monitoring the accuracy, precision, and utility of laboratory testing;
8.19	(3) analytical correlation and interpretation of test data; and
8.20	(4) designing, evaluating, and implementing new laboratory test methods.
8.21	The services provided by medical laboratory professionals must be consistent with good
8.22	practice and sound professional ethics.
8.23	Sec. 5. [148F.04] DUTIES OF COMMISSIONER.
8.24	The commissioner, with the advice of the advisory council, shall:
8.25	(1) administer the procedures for this chapter, including, but not limited to, verifying

1.28	(2) has met the medical laboratory experience and training required by the
1.29	recognized certification agencies; and
