Section 1. Minnesota Statutes 2018, section 169.829, is amended by adding a subdivision 1.6 to read: 1.7 Subd. 5. Sewage septic tank trucks. (a) Sections 169.823 to 169.828 do not apply to a 1.8 sewage septic tank truck used exclusively to transport sewage from septic or holding tanks. 1.9 (b) A vehicle that is transporting material pumped from a septic or holding tank must 1.10 travel on the most direct route between the septic or holding tank and the location where 1.11 the vehicle's contents are unloaded. 1.12 Sec. 2. Minnesota Statutes 2018, section 169.87, subdivision 6, is amended to read: 1.13 Subd. 6. Recycling and garbage vehicles. (c) Notwithstanding section 169.80, subdivision 1, a violation of weight restrictions imposed under subdivisions 1 and 2 by a vehicle designed and used exclusively for recycling while engaged in recycling in a political subdivision that mandates curbside recycling pickup while engaged in such collection, by a vehicle that is designed and used exclusively for collecting mixed municipal solid waste as defined in section 115A.03, subdivision 21, while engaged in such collection, or by a portable toilet service vehicle that is designed and used exclusively for collecting liquid waste from portable toilets, or by a sewage septic tank truck that is designed and used exclusively to haul sewage from septic or holding tanks while engaged in such collection, is not subject to criminal penalties but is subject to a civil penalty for excess weight under section 169.871.
