Section 1. Minnesota Statutes 2010, section 3.30, subdivision 2, is amended to read: 1.5 Subd. 2. Members; duties. The majority leader of the senate or a designee, the 1.6 minority leader of the senate or a designee, the chair of the senate Committee on Finance, 1.7 and the chair of the appropriate finance committee, or division of the senate Division of 1.8 Finance responsible for overseeing the items being considered by the commission, the 19 ranking minority member of the appropriate finance committee, or division of the senate 1.10 responsible for overseeing the items being considered by the commission, the speaker of 1.11 the house or a designee, the minority leader of the house of representatives or a designee, 1.12 the chair of the house of representatives Committee on Ways and Means, and the chair of 1.13 the appropriate finance committee, or division of the house of representatives committee 1.14 responsible for overseeing the items being considered by the <del>commissioner</del>, commission, 1.15 and the ranking minority member of the appropriate finance committee, or division of the 1.16 house of representatives committee responsible for overseeing the items being considered 1.17 by the commission constitute the Legislative Advisory Commission. The commissioner of management and budget shall be 2.4 secretary of the commission and keep a permanent record and minutes of its proceedings, 2.5 which are public records.
