A bill for an act

1.2 and public safety policies, including data practices and storage; motor carriers;
1.3 traffic regulation modifications; parking signs; advertising devices; vehicle
1.4 equipment; mini truck operation; railroad liability, powers, and crossing by
1.5 utilities; rail event response preparedness; minimum train crew size; drive away
1.6 in-transit licenses; road design; engine compression regulation by city of St. Paul;
1.7 turnbacks; bikeways; subcontracting goals; reporting requirements and alternative
1.8 damages appraisal for transportation projects; amending Minnesota Statutes
1.9 2014, sections 13.69, subdivision 1; 13.72, by adding a subdivision; 160.20,
1.10 subdivision 4; 160.232; 160.266, subdivisions 2, 3, by adding subdivisions;

1.22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.23 Section 1. Minnesota Statutes 2014, section 13.69, subdivision 1, is amended to read:

1.24 Subdivision 1. **Classifications.** (a) The following government data of the
1.25 Department of Public Safety are private data:

1.26 (1) medical data on driving instructors, licensed drivers, and applicants for parking
1.27 certificates and special license plates issued to physically disabled persons;

1.28 (2) other data on holders of a disability certificate under section 169.345, except that
1.29 data that are not medical data may be released to law enforcement agencies, and data
1.30 necessary for enforcement of sections 169.345 and 169.346 may be released to parking

2.1 enforcement employees or parking enforcement agents of statutory or home rule charter
 2.2 cities and towns;

2.3 (3) Social Security numbers in driver's license and motor vehicle registration
 2.4 records, except that Social Security numbers must be provided to the Department of
 2.5 Revenue for purposes of tax administration, the Department of Labor and Industry for
 2.6 purposes of workers' compensation administration and enforcement, and the Department
 2.7 of Natural Resources for purposes of license application administration; and

2.8 (4) data on persons listed as standby or temporary custodians under section 171.07,
 2.9 subdivision 11, except that the data must be released to:

2.10 (i) law enforcement agencies for the purpose of verifying that an individual is a
 2.11 designated caregiver; or

2.12 (ii) law enforcement agencies who state that the license holder is unable to
 2.13 communicate at that time and that the information is necessary for notifying the designated
 2.14 caregiver of the need to care for a child of the license holder.

2.15 The department may release the Social Security number only as provided in clause
 2.16 (3) and must not sell or otherwise provide individual Social Security numbers or lists of
 2.17 Social Security numbers for any other purpose.

2.18 (b) The following government data of the Department of Public Safety are
 2.19 confidential data: data concerning an individual's driving ability when that data is received
 2.20 from a member of the individual's family.

2.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.22 Sec. 2. Minnesota Statutes 2014, section 13.72, is amended by adding a subdivision to
 2.23 read:

2.24 **Subd. 20. Construction project schedule data.** A construction project schedule
 2.25 or any portion of a construction project schedule created by a vendor, as defined by
 2.26 section 16C.02, subdivision 21, and submitted to or maintained by the Department of
 2.27 Transportation is nonpublic data from the time the construction project is advertised
 2.28 until the project is awarded.

2.29 Sec. 3. Minnesota Statutes 2014, section 160.20, subdivision 4, is amended to read:

2.30 Subd. 4. **Conditions.** (a) A road authority may accept applications for permits for
 2.31 installation of drain tile along or across the right-of-way under its jurisdiction. The road
 2.32 authority may adopt reasonable rules for the installations and may require a bond before
 2.33 granting a permit. Permits for installation along a highway right-of-way must ensure that
 2.34 the length of the installation is restricted to the minimum necessary to achieve the desired

3.1 agricultural benefits. A permit must not allow open trenches to be left on the right-of-way
 3.2 after installation of the drain tile is completed. A road authority that grants a permit for
 3.3 tile drain installation is not responsible for damage to that installation resulting from the
 3.4 action of the authority or any other permittee utilizing the right-of-way.

3.5 (b) A person who installs drain tile along or across a highway right-of-way without
 3.6 obtaining a permit as provided in this section is guilty of a misdemeanor.

3.7 (c) The commissioner shall take no action under this section which will result in the
 3.8 loss of federal aid for highway construction in the state.

3.9 (d) For the purpose of ~~this section~~ subdivisions 2 to 4, "highway" means any
 3.10 highway as defined in section 160.02 which is located outside the corporate limits of a
 3.11 home rule charter or statutory city.

3.12 Sec. 4. Minnesota Statutes 2014, section 160.232, is amended to read:

3.13 **160.232 MOWING DITCHES ~~OUTSIDE CITIES~~.**

3.14 (a) To provide enhanced roadside habitat for nesting birds and other small wildlife,
 3.15 road authorities and persons may not mow, hay, or till the right-of-way of a highway
 3.16 ~~located outside of a home rule charter or statutory city~~ except as allowed in this section
 3.17 and section 160.23.

3.18 (b) On any highway, the first eight feet away from the road surface, or shoulder
 3.19 if one exists, may be mowed at any time.

3.20 (c) An entire right-of-way may be mowed ~~after July~~ from August 1 to December
 3.21 31. From August 31 January 1 to the following July 31, the entire right-of-way additional
 3.22 areas may only be mowed if necessary for safety reasons, but may not be mowed to a
 3.23 height of less than ~~12~~ eight inches.

3.24 (d) A right-of-way may be ~~mowed as necessary to maintain sight distance for safety~~
 3.25 ~~and may be mowed at other times under rules of the commissioner, or by ordinance of~~
 3.26 ~~a local road authority not conflicting with the rules of the commissioner~~ spot-mowed or
 3.27 precision-hayed for treatment of noxious weeds or invasive plant species, incorporating
 3.28 best management practices for long-term control.

3.29 (e) Residences and other areas traditionally maintained may be mowed, but
 3.30 landowners are encouraged to delay mowing the right-of-way until after nesting season.

3.31 (f) A right-of-way may be mowed, hayed, burned, or tilled to prepare ~~the right-of-way~~
 3.32 for the establishment of permanent vegetative cover or for prairie vegetation management.

3.33 (g) Roadsides adjacent to state wildlife management areas may not be mowed or
 3.34 hayed by persons other than road authorities unless permission to mow or hay the roadside
 3.35 is obtained from the commissioner of natural resources.

4.1 (h) Private land owners and public land owners may request that roadsides on their
 4.2 property not be mowed for the purpose of providing roadside habitat for wildlife or
 4.3 pollinators. The request must be made in writing to the appropriate road authority and
 4.4 shall include the legal description of the property.

4.5 (i) Local road authorities with roadside jurisdiction may create more restrictive
 4.6 mowing, haying, or tilling ordinances on roads under their jurisdiction.

4.7 ~~(f)~~ (j) When feasible, road authorities are encouraged to utilize low maintenance,
 4.8 native vegetation that reduces the need to mow, provides wildlife habitat, and maintains
 4.9 public safety.

4.10 ~~(g)~~ (k) The commissioner of natural resources shall ~~cooperate~~ coordinate with the
 4.11 commissioner of transportation and local road authorities to provide enhanced roadside
 4.12 habitat for nesting birds, native pollinators, and other small wildlife.

4.13 (l) Licensed peace officers may enforce this section. The penalty for a violation of
 4.14 this section is a petty misdemeanor and a civil penalty equal to the value of the vegetation
 4.15 taken as determined by the road authority. Penalties collected under this section must
 4.16 be deposited in an account maintained by the road authority with jurisdiction over the
 4.17 roadside impacted by the violation.

4.19 Subd. 2. **Creation.** The commissioner, in cooperation with road and trail authorities

 4.33 but not connected to the bikeway bikeways established in under this section, ~~including but~~

 5.7 to read:

5.8 Subd. 6. **Mississippi River Trail.** The Mississippi River Trail bikeway shall
 5.9 originate at Itasca State Park in Clearwater, Beltrami, and Hubbard Counties, then generally
 5.10 parallel the Mississippi River through the cities of Bemidji in Beltrami County, Grand
 5.11 Rapids in Itasca County, Brainerd in Crow Wing County, Little Falls in Morrison County,
 5.12 Sauk Rapids in Benton County, St. Cloud in Stearns County, Minneapolis in Hennepin
 5.13 County, St. Paul in Ramsey County, Hastings in Dakota County, Red Wing in Goodhue

 5.21 through the cities of North Branch in Chisago County, Hinckley in Pine County, Carlton in
 5.22 Carlton County, Duluth in St. Louis County, Two Harbors in Lake County, and Grand
 5.23 Marais in Cook County to Minnesota's boundary with Canada and there terminate.

5.24 Sec. 9. Minnesota Statutes 2014, section 161.088, subdivision 3, is amended to read:

5.25 **Subd. 3. Project classification.** The commissioner shall determine whether each
 5.26 candidate project can be classified into at least one of the following classifications:

5.27 (1) capacity development, for a project on a segment of a trunk highway where the
 5.28 segment:

5.29 (i) is not a divided highway, and that highway is an expressway or freeway beyond
 5.30 the project limits;

5.31 (ii) contains a highway terminus that lacks an intersection or interchange with
 5.32 another trunk highway;

6.1 (iii) contains fewer lanes of travel compared to that highway beyond the project
6.2 limits; or

6.3 (iv) contains a location that is proposed as a new interchange or to be reconstructed
6.4 from an intersection to an interchange; or

6.5 (2) freight improvement, for an asset preservation or replacement project that can
6.6 result in:

6.7 (i) removing or reducing barriers to commerce;

6.16 Sec. 10. Minnesota Statutes 2014, section 161.088, subdivision 4, is amended to read:

6.17 Subd. 4. **Project eligibility.** (a) The commissioner shall establish eligibility
6.18 requirements for projects that can be funded under the program. Eligibility must include:

6.19 (1) consistency with the statewide multimodal transportation plan under section
6.20 174.03;

6.21 (2) location of the project on an interregional corridor, for a project located outside
6.22 of the Department of Transportation metropolitan district, or within a city;

6.23 (3) placement into at least one project classification under subdivision 3;

6.24 (4) a maximum length of time, as determined by the commissioner, until
6.25 commencement of construction work on the project; and

6.26 (5) for each type of project classification under subdivision 3, a maximum allowable

7.1 Subd. 5. **Project selection process; criteria.** (a) The commissioner shall establish a
7.2 process for identification, evaluation, and selection of projects under the program.

7.3 (b) As part of the project selection process, the commissioner shall annually accept
7.4 recommendations on candidate projects from area transportation partnerships and other
7.5 interested stakeholders in each Department of Transportation district. For each candidate
7.6 project identified under this paragraph, the commissioner shall determine eligibility,
7.7 classify, and if appropriate, evaluate the project for the program.

7.8 (c) Project evaluation and prioritization must be performed on the basis of objective
7.9 criteria, which must include:

7.23 objectives and principles; and

7.24 (7) support and consensus for the project among members of the surrounding
7.25 community.

7.26 (d) As part of the project selection process, the commissioner may divide funding
7.27 to be separately available among projects within each classification under subdivision 3,
7.28 and may apply separate or modified criteria among those projects falling within each
7.29 classification.

7.31 In all highway construction and maintenance projects, the commissioner shall, to
7.32 the greatest extent feasible, utilize products, materials, and equipment that are made in
7.33 America and shall include this requirement in the department's contract specifications.

7.34 Sec. 13. Minnesota Statutes 2014, section 161.321, subdivision 2a, is amended to read:

8.1 Subd. 2a. **Small targeted group business; subcontracting goals.** (a) The
 8.2 commissioner, ~~as a condition of awarding a construction contract,~~ may set goals that
 8.3 ~~require the~~ for targeted group business participation in contracts. As a condition of award,
 8.4 the prime contractor is required to subcontract portions of the contract to small targeted
 8.5 group businesses. Prime contractors must demonstrate good faith efforts to meet the
 8.6 project goals. The commissioner shall establish a procedure for granting waivers from
 8.7 the subcontracting requirement when qualified small targeted group businesses are not
 8.8 reasonably available either meet the goal or demonstrate good faith efforts to meet the
 8.9 goal. The commissioner must establish a procedure for evaluating the good faith efforts
 8.10 of contractors that do not meet the goal. The commissioner may establish (1) financial
 8.11 incentives for prime contractors who exceed the goals set for the use of subcontractors
 8.12 under this subdivision; and (2) sanctions for prime contractors who fail to make good faith
 8.13 efforts to meet the goals set under this subdivision.

8.14 (b) The small targeted group business subcontracting requirements of this
 8.15 subdivision do not apply to prime contractors who are small targeted group businesses.

8.17 Subd. 2c. **Veteran-owned small business; subcontracting goals.** (a) The

 8.19 ~~require the prime contractor to subcontract portions of the contract to veteran-owned small~~
 8.20 ~~businesses~~ for veteran-owned small business participation in contracts, except when
 8.21 prohibited by federal law or rule as a condition of receiving federal funds. As a condition
 8.22 of award, the prime contractors contractor must either meet the goal or demonstrate good
 8.23 faith efforts to meet the project goals. The commissioner shall ~~shall~~ must establish a procedure
 8.24 for granting waivers from the subcontracting requirement when qualified veteran-owned
 8.25 small businesses are not reasonably available evaluating the good faith efforts of

9.5 (a) On behalf of the state, the commissioner may enter into agreements with Indian
9.6 tribal authorities for the purpose of providing maintenance, design, and construction to
9.7 highways on tribal lands. These agreements may include (1) a provision for waiver of
9.8 immunity from suit by a party to the contract on the part of the tribal authority with respect
9.9 to any controversy arising out of the contract and (2) a provision conferring jurisdiction on
9.10 state district courts to hear such a controversy.

9.11 (b) Notwithstanding section 161.32, for construction of highways on tribal lands
9.12 in a reservation exempt from Public Law 83-280, the commissioner may: (1) award
9.13 a preference for Indian-owned contractors to the same extent provided in the applicable

9.22 Subd. 2. **Deputy registrars.** (a) The commissioner may appoint, and for cause
9.23 discontinue, a deputy registrar for any statutory or home rule charter city as the public
9.24 interest and convenience may require, without regard to whether the county auditor of
9.25 the county in which the city is situated has been appointed as the deputy registrar for the
9.26 county or has been discontinued as the deputy registrar for the county, and without regard
9.27 to whether the county in which the city is situated has established a county license bureau
9.28 that issues motor vehicle licenses as provided in section 373.32.

9.29 (b) The commissioner may appoint, and for cause discontinue, a deputy registrar
9.30 for any statutory or home rule charter city as the public interest and convenience may

10.3 (d) Despite any other provision, a person other than a county auditor or a director
10.4 of a county license bureau, who was appointed by the registrar before August 1, 1976,
10.5 as a deputy registrar for any statutory or home rule charter city, may continue to serve
10.6 as deputy registrar and may be discontinued for cause only by the commissioner. The
10.7 county auditor who appointed the deputy registrars is responsible for the acts of deputy
10.8 registrars appointed by the auditor.

10.9 (e) Each deputy, before entering upon the discharge of duties, shall take and
10.10 subscribe an oath to faithfully discharge the duties and to uphold the laws of the state.

10.11 (f) If a deputy registrar appointed under this subdivision is not an officer or employee
10.12 of a county or statutory or home rule charter city, the deputy shall in addition give bond to
10.13 the state in the sum of \$10,000, or a larger sum as may be required by the commissioner,

10.27 the transaction and subject to standards established by the commissioner. The deputy
10.28 registrar is responsible for all costs associated with the conversion to electronic records
10.29 and maintenance of the electronic storage medium, including the destruction of existing

10.31 deputy registrar must at all times be open to the inspection of the commissioner or the

31.19 (8) discuss options for use of tolling revenue and measures to ensure compliance
 31.20 with laws concerning operation of toll roads and use of revenues;

31.21 (9) recommend and discuss possible ways to reduce cost to Minnesotans, such as tax
 31.22 deductions or credits, or types of discounts; and

31.23 (10) provide recommendations for needed statutory or rule changes that would
 31.24 facilitate wider implementation of tolling and achieve maximum revenues for the state
 31.25 and equity for its residents.

31.26 **EFFECTIVE DATE.** This section is effective the day following final enactment.

31.27 Sec. 55. **COST SHARE POLICY.**

31.28 The commissioner of transportation, in consultation with representatives of local
 31.29 units of government, shall create and adopt a policy concerning cost participation
 31.30 for cooperative construction projects and maintenance responsibilities between the
 31.31 Department of Transportation and local units of government. The policy must minimize
 31.32 the share of cooperative project costs to be funded by the local units of government,
 31.33 while complying in all respects with the state constitutional requirements concerning
 31.34 allowable uses of the trunk highway fund. The policy must be completed and adopted by
