1.8	Subdivision 1. Reverse referendum; certain leases. (a) Before executing a qualified
1.9	lease, a municipality must publish notice of its intention to execute the lease and the date
1.10	and time of a hearing to obtain public comment on the matter. The notice must be published
1.11	in the official newspaper of the municipality or in a newspaper of general circulation in the
1.12	municipality and must include a statement of the amount of the obligations to be issued by
1.13	the authority and the maximum amount of annual rent to be paid by the municipality under
1.14	the qualified lease. The notice must be published at least 14, but not more than 28, days
1.15	before the date of the hearing.
1.16	(b) A municipality may enter a lease subject to paragraph (a) only upon obtaining the
1.17	approval of a majority of the voters voting on the question of issuing the obligations, if a
1.18	petition requesting a vote on the issuance is signed by voters equal to five percent of the
1.19	votes cast in the municipality in the last general election and is filed with the county auditor
1.20	within 30 days after the public hearing.
