Minnesota Statutes 2012, section 256B.5012, is amended by adding a 1.7 subdivision to read: 18 Subd. 16. ICF/DD rate increases effective July 1, 2014. (a) For the rate period 1.9 beginning July 1, 2014, the commissioner shall increase operating payments for each 1.10 facility reimbursed under this section equal to five percent of the operating payment 1 11 rates in effect on June 30, 2014. 1.12 (b) For each facility, the commissioner shall apply the rate increase based on 1 13 occupied beds, using the percentage specified in this subdivision multiplied by the total 1.14 payment rate, including the variable rate but excluding the property-related payment 1.15 rate in effect on the preceding date.
