1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2020, section 219.015, subdivision 1, is amended to read:
1.6	Subdivision 1. Positions Program established; inspector powers and duties. (a) The
1.7	commissioner of transportation shall must establish three a state rail safety inspector positions
1.8	in the Office of Freight and Commercial Vehicle Operations of the Minnesota Department
1.9	of Transportation. On or after July 1, 2015, the commissioner may establish a fourth state
1.10	rail safety inspector position following consultation with railroad companies inspection
1.11	program that may include state rail safety inspectors and supervision as determined by the
1.12	commissioner. The commissioner shall apply to and enter into agreements with the Federal
1.13	Railroad Administration (FRA) of the United States Department of Transportation to
1.14	participate in the federal State Rail Safety Participation Program for training and certification

1.18	(b) A state rail safety inspector shall may:

1.21	bridges, overhead structures, and traffic and other public crossings;

## 3.6 **219.1651 GRADE CROSSING SAFETY ACCOUNT.**

A Minnesota grade crossing safety account is created in the special revenue fund, consisting of money credited to the account by law. Money in the account is appropriated to the commissioner of transportation for rail-highway grade crossing safety projects on public streets and highways, including engineering costs and other costs associated with administration and delivery of grade crossing safety projects. At the discretion of the commissioner of transportation, money in the account at the end of each biennium may cancel to the trunk highway fund.
