1.6	Section 1. [136F.38] WORKFORCE DEVELOPMENT SCHOLARSHIPS.
1.7	Subdivision 1. Program established. The board shall develop a scholarship program
1.8	to incentivize new students to enter high-demand occupations upon graduation.
1.9	Subd. 2. Scholarship awards. The program shall award scholarships at the beginning
1.10	of an academic term, in the amount of \$2,500, to be distributed evenly between two terms.
1.11	Subd. 3. Program eligibility. (a) Scholarships shall be awarded only to a student eligible
1.12	for resident tuition, as defined in section 135A.043, who is enrolled in any of the following
