## 609.74 PUBLIC NUISANCE. 2.23

- Whoever by an act or failure to perform a legal duty intentionally does any of the 2.24 following is guilty of maintaining a public nuisance, which is a misdemeanor: 2.25
- (1) maintains or permits a condition which unreasonably annoys, injures or endangers 2.26 the safety, health, morals, comfort, or repose of any considerable number of members of 2.27 the public; or 2.28
- (2) interferes with, obstructs, or renders dangerous for passage, any public highway or 2.29 right-of-way, or waters used by the public; or 2.30

- (3) is guilty of any other act or omission declared by law to be a public nuisance and forwhich no sentence is specifically provided.
- 3.3 **EFFECTIVE DATE.** This section is effective the day following final enactment and applies to acts committed on or after that date.
