1.6	Section 1. STATE PARKS AND TRAILS.
1.7	Subdivision 1. Trails acquisition and development. (a) \$20,950,000 is
1.8	appropriated from the bond proceeds fund to the commissioner of natural resources to
1.9	acquire land for and to construct state trails under Minnesota Statutes, section 85.015.
1.10	This appropriation includes funding for the following trail projects:
1.11	(1) \$500,000 to acquire land for and develop approximately four miles of the
1.12	Blazing Star Trail from Myre-Big Island State Park to Hayward;
1.13	(2) \$750,000 to develop and pave approximately five miles of the Casey Jones
