BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.11 1.12 Section 1. [15.0146] COUNCIL ON LGBTQIA MINNESOTANS. Subdivision 1. Council established; membership. (a) The Council on LGBTQIA 1.13 Minnesotans is established. The council consists of 16 voting members, appointed as provided 1.14 in this subdivision. The governor may additionally appoint a commissioner of a state agency 1.15 or a designee of that commissioner to serve as an ex officio, nonvoting member of the 1.16 council. 1.17 (b) The governor shall appoint a total of 12 public voting members as follows: two 1.18 members who identify as gay, two members who identify as lesbian, two members who 1.19 identify as bisexual, two members who identify as transgender, two members who identify 1.20 as queer, and two members who identify as intersex. 1.21 (c) Four legislators shall be appointed to the council as follows: the speaker of the house 1.22 and the minority leader of the house of representatives shall each appoint one member of 1.23

(a) In making appointments to the council, 2.3 the governor shall consider an appointee's proven dedication and commitment to Minnesota's 2.4 2.5 LGBTQIA community and any expertise possessed by the appointee that might be beneficial to the council, such as experience in public policy, legal affairs, social work, business, or 2.6 management. The executive director and legislative members may offer advice to the 2.7 governor on applicants seeking appointment. 2.8 (b) Terms, compensation, and filling of vacancies for members appointed by the governor 2.9 are as provided in section 15.059. Removal of members appointed by the governor is 2.10 governed by section 15.059, except that: (1) a member who missed more than half of the 2.11 council meetings convened during a 12-month period is automatically removed from the 2.12 council; and (2) a member appointed by the governor may be removed by a vote of three 2.13 of the four legislative members of the council. The chair of the council shall inform the 2.14 governor of the need for the governor to fill a vacancy on the council. Legislative members 2.15 serve at the pleasure of their appointing authority. 2.16 (c) A member appointed by the governor may serve no more than a total of eight years 2.17 on a council. Subd. 7. Reports. The council must report on the measurable outcomes achieved in the council's current strategic plan to meet its statutory duties, along with the specific objectives and outcome measures proposed for the following year. The council must submit the report by January 15 each year to the chairs and ranking minority members of the legislative committees with primary jurisdiction over state government operations. Each report must cover the calendar year of the year before the report is submitted. The specific objectives and outcome measures for the following current year must focus on three or four achievable objectives, action steps, and measurable outcomes for which the council will be held accountable. The strategic plan may include other items that support the statutory purposes of the council but should not distract from the primary statutory proposals presented. The biennial budget of each council must be submitted to the Legislative Coordinating Commission by February 1 in each odd-numbered year.

The working group shall consist of one board member from each of the following boards:

## 609.20 MANSLAUGHTER IN THE FIRST DEGREE.

**REVISOR** 

Whoever does any of the following is guilty of manslaughter in the first degree and may be sentenced to imprisonment for not more than 15 years or to payment of a fine of not more than \$30,000, or both:

- (1) intentionally causes the death of another person in the heat of passion provoked by such words or acts of another as would provoke a person of ordinary self-control under like circumstances, provided that:
  - (i) the crying of a child; or
- (ii) the discovery of, knowledge about, or potential disclosure of the victim's actual or perceived sexual orientation, including gender identity and expression, including under circumstances in which the victim made an unwanted nonforcible romantic or sexual advance toward the actor, or if the actor and victim dated or had a romantic or sexual relationship; does not constitute provocation;
- (2) violates section 609.224 and causes the death of another or causes the death of another in committing or attempting to commit a misdemeanor or gross misdemeanor offense with such force and violence that death of or great bodily harm to any person was reasonably foreseeable, and murder in the first or second degree was not committed thereby;
- (3) intentionally causes the death of another person because the actor is coerced by threats made by someone other than the actor's coconspirator and which cause the actor reasonably to believe that the act performed by the actor is the only means of preventing imminent death to the actor or another;
- (4) proximately causes the death of another, without intent to cause death by, directly or indirectly, unlawfully selling, giving away, bartering, delivering, exchanging, distributing, or administering a controlled substance classified in Schedule III, IV, or V; or
- (5) causes the death of another in committing or attempting to commit a violation of section 609.377 (malicious punishment of a child), and murder in the first, second, or third degree is not committed thereby.
- As used in this section, a "person of ordinary self-control" does not include a person under the influence of intoxicants or a controlled substance.
