1.6	Section 1. [256E.38] DIAPER DISTRIBUTION GRANT PROGRAM.
1.7	Subdivision 1. Establishment; purpose. The commissioner of human services shall
1.8	establish a diaper distribution program to award competitive grants to eligible applicants
1.9	to provide diapers to underresourced families statewide.
