relating to capital investment; appropriating money for a separated rail grade

crossing of 11th Street in the city of Moorhead; authorizing the sale and issuance

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6

Section 1. **MOORHEAD; 11TH STREET RAIL GRADE CROSSING.**

1.7

Subdivision 1. **Appropriation.** \$7,000,000 is appropriated from the bond proceeds fund

1.8

to the commissioner of transportation for a grant to the city of Moorhead for predesign,

1.9

environmental assessment, environmental work, design, engineering, utility relocation, and

1.10

acquisition of property for a rail grade crossing separation in the vicinity of 11th Street in

1.11

the city of Moorhead. This appropriation is available when the commissioner of management

1.12

and budget determines that sufficient resources have been committed to complete the project

1.13

as required by Minnesota Statutes, section 16A.502.

1.14

Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond

1.15

proceeds fund, the commissioner of management and budget shall sell and issue bonds of

1.16

the state in an amount up to \$7,000,000 in the manner, upon the terms, and with the effect

1.17

prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota

1.18

Constitution, article XI, sections 4 to 7.

1.19

EFFECTIVE DATE. This section is effective the day following final enactment.
