1.9	Section 1. Minnesota Statutes 2014, section 152.22, subdivision 14, is amended to read:
1.10	Subd. 14. Qualifying medical condition. "Qualifying medical condition" means a
1.11	diagnosis of any of the following conditions:
1.12	(1) cancer, if the underlying condition or treatment produces one or more of the
1.13	following:
1.14	(i) severe or chronic pain;
1.15	(ii) nausea or severe vomiting; or
1.16	(iii) cachexia or severe wasting;
1.17	(2) glaucoma;
1.18	(3) human immunodeficiency virus or acquired immune deficiency syndrome;
1.19	(4) Tourette's syndrome;
1.20	(5) amyotrophic lateral sclerosis;

(a) A manufacturer shall operate 2.9 four distribution facilities, which may include the manufacturer's single location for 2.10 cultivation, harvesting, manufacturing, packaging, and processing but is not required to 2.11 include that location. A manufacturer is required to begin distribution of medical cannabis 2.12 from at least one distribution facility by July 1, 2015. All distribution facilities must be 2.13 operational and begin distribution of medical cannabis by July 1, 2016. 2.14 (b) Within three months after the date on which at least 2,000 patients are enrolled in 2.15 the registry program, a manufacturer authorized to operate in even-numbered congressional 2.16 districts must operate at least two distribution facilities. 3.16	(f) A manufacturer shall not permit any person to consume medical cannabis on
3.17	the property of the manufacturer.
3.18	(g) A manufacturer is subject to reasonable inspection by the commissioner.
3.19	(h) For purposes of sections 152.22 to 152.37, a medical cannabis manufacturer is not
3.20	subject to the Board of Pharmacy licensure or regulatory requirements under chapter 151.
3.21	(i) A medical cannabis manufacturer may not employ any person who is under 21
3.22	years of age or who has been convicted of a disqualifying felony offense. An employee of
3.23	a medical cannabis manufacturer must submit a completed criminal history records check
3.24	consent form, a full set of classifiable fingerprints, and the required fees for submission

For purposes of this clause, a 4.20 consultation may be conducted remotely using a videoconference, so long as the employee 4.21 4.22 providing the consultation is able to confirm the identity of the patient, the consultation occurs while the patient is at a distribution facility, and the consultation adheres to patient 4.23 privacy requirements that apply to health care services delivered through telemedicine; 4.24 4.25 (5) properly package medical cannabis in compliance with the United States Poison Prevention Packing Act regarding child-resistant packaging and exemptions for 4.26 packaging for elderly patients, and label distributed medical cannabis with a list of all 4.27 active ingredients and individually identifying information, including: 4.28
