BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. [150A.051] DENTIST AND DENTAL HYGIENIST COMPACT.

The dentist and dental hygienist compact is enacted into law and entered into with all other jurisdictions legally joining in the compact in the form substantially specified in this section.

## ARTICLE 1. TITLE AND PURPOSE

This statute shall be known and cited as the dentist and dental hygienist compact. The purposes of this compact are to facilitate the interstate practice of dentistry and dental hygiene and improve public access to dentistry and dental hygiene services by providing dentists and dental hygienists licensed in a participating state the ability to practice in participating states in which they are not licensed. The compact does this by establishing a pathway for a dentists and dental hygienists licensed in a participating state to obtain a compact privilege that authorizes them to practice in another participating state in which they are not licensed. The compact enables participating states to protect the public health and safety with respect to the practice of such dentists and dental hygienists, through the state's authority to regulate the practice of dentistry and dental hygiene in the state. The compact:

2.1	(A) enables dentists and dental hygienists who qualify for a compact privilege to practice
2.2	in other participating states without satisfying burdensome and duplicative requirements
2.3	associated with securing a license to practice in those states;
2.4	(B) promotes mobility and addresses workforce shortages through each participating
2.5	state's acceptance of a compact privilege to practice in that state;
2.6	(C) increases public access to qualified, licensed dentists and dental hygienists by creating
2.7	a responsible, streamlined pathway for licensees to practice in participating states;
2.8	(D) enhances the ability of participating states to protect the public's health and safety;
2.9	(E) does not interfere with licensure requirements established by a participating state;
2.10	(F) facilitates the sharing of licensure and disciplinary information among participating
2.11	states;
2.12	(G) requires dentists and dental hygienists who practice in a participating state pursuant
2.13	to a compact privilege to practice within the scope of practice authorized in that state;
2.14	(H) extends the authority of a participating state to regulate the practice of dentistry and
2.15	dental hygiene within its borders to dentists and dental hygienists who practice in the state
2.16	through a compact privilege;
2.17	(I) promotes the cooperation of participating states in regulating the practice of dentistry
2.18	and dental hygiene within those states; and
2.19	(J) facilitates the relocation of military members and their spouses who are licensed to
2.20	practice dentistry or dental hygiene.
2.21	ARTICLE 2. DEFINITIONS
2.22	As used in this compact, unless the context requires otherwise, the following definitions
2.23	shall apply:
2.24	(A) "Active military member" means any person with full-time duty status in the armed
2.25	forces of the United States including members of the National Guard and Reserve.
2.26	(B) "Adverse action" means disciplinary action or encumbrance imposed on a license
2.27	or compact privilege by a state licensing authority.
2.28	(C) "Alternative program" means a nondisciplinary monitoring or practice remediation
2.29	process applicable to a dentist or dental hygienist approved by a state licensing authority
2.30	of a participating state in which the dentist or dental hygienist is licensed. This includes but

is not limited to programs to which licensees with substance abuse or addiction issues are 3.1 referred in lieu of adverse action. 3.2 (D) "Clinical assessment" means examination or process, required for licensure as a 3.3 dentist or dental hygienist as applicable, that provides evidence of clinical competence in 3.4 3.5 dentistry or dental hygiene. (E) "Commissioner" means the individual appointed by a participating state to serve as 3.6 the member of the commission for that participating state. 3.7 (F) "Compact" means this dentist and dental hygienist compact. 3.8 (G) "Compact privilege" means the authorization granted by a remote state to allow a 3.9 licensee from a participating state to practice as a dentist or dental hygienist in a remote 3.10 3.11 state. (H) "Continuing professional development" means a requirement as a condition of license 3.12 renewal to provide evidence of successful participation in educational or professional 3.13 activities relevant to practice or area of work. 3.14 (I) "Criminal background check" means the submission of fingerprints or other 3.15 biometric-based information for a license applicant for the purpose of obtaining that 3.16 applicant's criminal history record information, as defined in Code of Federal Regulations, 3.17 title 28, section 20.3(d), from the Federal Bureau of Investigation and the state's criminal 3.18 history record repository as defined in Code of Federal Regulations, title 28, section 20.3(f). 3.19 (J) "Data system" means the commission's repository of information about licensees, 3.20 including but not limited to examination, licensure, investigative, compact privilege, adverse 3.21 action, and alternative program. 3.22 (K) "Dental hygienist" means an individual who is licensed by a state licensing authority 3.23 to practice dental hygiene. 3.24 (L) "Dentist" means an individual who is licensed by a state licensing authority to practice 3.25 dentistry. 3.26 (M) "Dentist and dental hygienist compact commission" or "commission" means a joint 3.27 government agency established by this compact comprised of each state that has enacted 3.28 the compact and a national administrative body comprised of a commissioner from each 3.29 state that has enacted the compact. 3.30 (N) "Encumbered license" means a license that a state licensing authority has limited in 3.31 any way other than through an alternative program. 3.32

(O) "Executive board" means the chair, vice chair, secretary, and treasurer and any other 4.1 commissioners as may be determined by commission rule or bylaw. 4.2 (P) "Jurisprudence requirement" means the assessment of an individual's knowledge of 4.3 the laws and rules governing the practice of dentistry or dental hygiene, as applicable, in a 4.4 4.5 state. (Q) "License" means current authorization by a state, other than authorization pursuant 4.6 to a compact privilege, or other privilege, for an individual to practice as a dentist or dental 4.7 hygienist in that state. 4.8 (R) "Licensee" means an individual who holds an unrestricted license from a participating 4.9 state to practice as a dentist or dental hygienist in that state. 4.10 (S) "Model compact" means the model for the dentist and dental hygienist compact on 4.11 file with the council of state governments or other entity as designated by the commission. 4.12 (T) "Participating state" means a state that has enacted the compact and been admitted 4.13 to the commission in accordance with the provisions herein and commission rules. 4.14 (U) "Qualifying license" means a license that is not an encumbered license issued by a 4.15 participating state to practice dentistry or dental hygiene. 4.16 (V) "Remote state" means a participating state where a licensee who is not licensed as 4.17 a dentist or dental hygienist is exercising or seeking to exercise the compact privilege. 4.18 (W) "Rule" means a regulation promulgated by an entity that has the force of law. 4.19 (X) "Scope of practice" means the procedures, actions, and processes a dentist or dental 4.20 hygienist licensed in a state is permitted to undertake in that state and the circumstances 4.21 under which the licensee is permitted to undertake those procedures, actions, and processes. 4.22 Such procedures, actions, and processes and the circumstances under which they may be 4.23 undertaken may be established through means, including but not limited to statute, 4.24 regulations, case law, and other processes available to the state licensing authority or other 4.25 government agency. 4.26 (Y) "Significant investigative information" means information, records, and documents 4.27 received or generated by a state licensing authority pursuant to an investigation for which 4.28 a determination has been made that there is probable cause to believe that the licensee has 4.29 violated a statute or regulation that is considered more than a minor infraction for which 4.30 the state licensing authority could pursue adverse action against the licensee. 4.31

(Z) "State" means any state, commonwealth, district, or territory of the United States of 5.1 America that regulates the practices of dentistry and dental hygiene. 5.2 (AA) "State licensing authority" means an agency or other entity of a state that is 5.3 responsible for the licensing and regulation of dentists or dental hygienists. 5.4 5.5 ARTICLE 3. STATE PARTICIPATION IN THE COMPACT (A) In order to join the compact and thereafter continue as a participating state, a state 5.6 must: 5.7 (1) enact a compact that is not materially different from the model compact as determined 5.8 in accordance with commission rules; 5.9 (2) participate fully in the commission's data system; 5.10 5.11 (3) have a mechanism in place for receiving and investigating complaints about its licensees and license applicants; 5.12 (4) notify the commission, in compliance with the terms of the compact and commission 5.13 rules, of any adverse action or the availability of significant investigative information 5.14 regarding a licensee and license applicant; 5.15 (5) fully implement a criminal background check requirement, within a time frame 5.16 established by commission rule, by receiving the results of a qualifying criminal background 5.17 check; 5.18 5.19 (6) comply with the commission rules applicable to a participating state; (7) accept the national board examinations of the joint commission on national dental 5.20 examinations or another examination accepted by commission rule as a licensure 5.21 examination; 5.22 (8) accept for licensure that applicants for a dentist license graduate from a predoctoral 5.23 dental education program accredited by the Commission on Dental Accreditation, or another 5.24 accrediting agency recognized by the United States Department of Education for the 5.25 5.26 accreditation of dentistry and dental hygiene education programs, leading to the Doctor of Dental Surgery (D.D.S.) or Doctor of Dental Medicine (D.M.D.) degree; 5.27 (9) accept for licensure that applicants for a dental hygienist license graduate from a 5.28 dental hygiene education program accredited by the Commission on Dental Accreditation 5.29 or another accrediting agency recognized by the United States Department of Education for 5.30 the accreditation of dentistry and dental hygiene education programs; 5.31 (10) require for licensure that applicants successfully complete a clinical assessment; 5.32

that adverse action applies to all compact privileges in all remote states. A licensee whose compact privilege in a remote state is removed for a specified period of time is not eligible for a compact privilege in any other remote state until the specific time for removal of the compact privilege has passed and all encumbrance requirements are satisfied. (E) If a license in a participating state is an encumbered license, the licensee shall lose the compact privilege in a remote state and shall not be eligible for a compact privilege in any remote state until the license is no longer encumbered. (F) Once an encumbered license in a participating state is restored to good standing, the licensee must meet the requirements of (A) of this article to obtain a compact privilege in a remote state. (G) If a licensee's compact privilege in a remote state is removed by the remote state, the individual shall lose or be ineligible for the compact privilege in any remote state until the following occur: (1) the specific period of time for which the compact privilege was removed has ended; and (2) all conditions for removal of the compact privilege have been satisfied. (H) Once the requirements of (G) of this article have been met, the licensee must meet the requirements in (A) of this article to obtain a compact privilege in a remote state. ARTICLE 5. ACTIVE MILITARY MEMBER OR THEIR SPOUSES An active military member and their spouse shall not be required to pay to the commission for a compact privilege the fee otherwise charged by the commission. If a remote state chooses to charge a fee for a compact privilege, it may choose to charge a reduced fee or no fee to an active military member and their spouse for a compact privilege. ARTICLE 6. ADVERSE ACTIONS (A) A participating state in which a licensee is licensed shall have exclusive authority to impose adverse action against the qualifying license issued by that participating state. (B) A participating state may take adverse action based on the significant investigative information of a remote state, so long as the participating state follows its own procedures for imposing adverse action. (C) Nothing in this compact shall override a participating state's decision that participation in an alternative program may be used in lieu of adverse action and that such participation

shall remain nonpublic if required by the participating state's laws. Participating states must

require licensees who enter any alternative program in lieu of discipline to agree not to practice pursuant to a compact privilege in any other participating state during the term of the alternative program without prior authorization from such other participating state.

- (D) Any participating state in which a licensee is applying to practice or is practicing pursuant to a compact privilege may investigate actual or alleged violations of the statutes and regulations authorizing the practice of dentistry or dental hygiene in any other participating state in which the dentist or dental hygienist holds a license or compact privilege.
  - (E) A remote state shall have the authority to:

- (1) take adverse actions as set forth in Article 4(D) against a licensee's compact privilege in the state;
- (2) in furtherance of its rights and responsibilities under the compact and the commission's rules issue subpoenas for both hearings and investigations that require the attendance and testimony of witnesses, and the production of evidence. Subpoenas issued by a state licensing authority in a participating state for the attendance and testimony of witnesses, or the production of evidence from another participating state, shall be enforced in the latter state by any court of competent jurisdiction, according to the practice and procedure of that court applicable to subpoenas issued in proceedings pending before it. The issuing authority shall pay any witness fees, travel expenses, mileage, and other fees required by the service statutes of the state where the witnesses or evidence are located; and
- (3) if otherwise permitted by state law, recover from the licensee the costs of investigations and disposition of cases resulting from any adverse action taken against that licensee.
  - (F) Joint Investigations:
- (1) In addition to the authority granted to a participating state by its dentist or dental hygienist licensure act or other applicable state law, a participating state may jointly investigate licensees with other participating states.
- (2) Participating states shall share any significant investigative information, litigation, or compliance materials in furtherance of any joint or individual investigation initiated under the compact.
  - (G) Authority to Continue Investigation:

(1) After a licensee's compact privilege in a remote state is terminated, the remote state 10.1 may continue an investigation of the licensee that began when the licensee had a compact 10.2 10.3 privilege in that remote state. (2) If the investigation yields what would be significant investigative information had 10.4 10.5 the licensee continued to have a compact privilege in that remote state, the remote state shall report the presence of such information to the data system as required by Article 8(B)(6) 10.6 as if it was significant investigative information. 10.7 ARTICLE 7. ESTABLISHMENT AND OPERATION OF THE COMMISSION 10.8 (A) The compact participating states hereby create and establish a joint government 10.9 agency whose membership consists of all participating states that have enacted the compact. 10.10 The commission is an instrumentality of the participating states acting jointly and not an 10.11 10.12 instrumentality of any one state. The commission shall come into existence on or after the effective date of the compact as set forth in Article 11(A). 10.13 10.14 (B) Participation, Voting, and Meetings: (1) Each participating state shall have and be limited to one commissioner selected by 10.15 10.16 that participating state's state licensing authority or, if the state has more than one state licensing authority, selected collectively by the state licensing authorities. 10.17 (2) The commissioner shall be a member or designee of such authority or authorities. 10.18 (3) The commission may by rule or bylaw establish a term of office for commissioners 10.19 and may by rule or bylaw establish term limits. 10.20 (4) The commission may recommend to a state licensing authority or authorities, as 10.21 applicable, removal or suspension of an individual as the state's commissioner. 10.22 (5) A participating state's state licensing authority or authorities, as applicable, shall fill 10.23 any vacancy of its commissioner on the commission within 60 days of the vacancy. 10.24 (6) Each commissioner shall be entitled to one vote on all matters that are voted upon 10.25 by the commission. 10.26 10.27 (7) The commission shall meet at least once during each calendar year. Additional meetings may be held as set forth in the bylaws. The commission may meet by 10.28 telecommunication, video conference, or other similar electronic means. 10.29 (C) The commission shall have the following powers: 10.30 10.31 (1) establish the fiscal year of the commission;

- (1) The commission shall pay, or provide for the payment of, the reasonable expenses of its establishment, organization, and ongoing activities.
- (2) The commission may accept any and all appropriate sources of revenue, donations, and grants of money, equipment, supplies, materials, and services.
  - (3) The commission may levy on and collect an annual assessment from each participating state and impose fees on licensees of participating states when a compact privilege is granted to cover the cost of the operations and activities of the commission and its staff, which must be in a total amount sufficient to cover its annual budget as approved each fiscal year for which sufficient revenue is not provided by other sources. The aggregate annual assessment amount for participating states shall be allocated based upon a formula that the commission shall promulgate by rule.
  - (4) The commission shall not incur obligations of any kind prior to securing the funds adequate to meet the same; nor shall the commission pledge the credit of any participating state, except by and with the authority of the participating state.
  - (5) The commission shall keep accurate accounts of all receipts and disbursements. The receipts and disbursements of the commission shall be subject to the financial review and accounting procedures established under the commission's bylaws. All receipts and disbursements of funds handled by the commission shall be subject to an annual financial review by a certified or licensed public accountant, and the report of the financial review shall be included in and become part of the annual report of the commission.

#### (F) The Executive Board:

- (1) The executive board shall have the power to act on behalf of the commission according to the terms of this compact. The powers, duties, and responsibilities of the executive board shall include:
- (i) overseeing the day-to-day activities of the administration of the compact including compliance with the provisions of the compact and the commission's rules and bylaws;

(G) Qualified Immunity, Defense, and Indemnification:

- (1) The members, officers, executive director, employees, and representatives of the commission shall be immune from suit and liability, both personally and in their official capacity, for any claim for damage to or loss of property or personal injury or other civil liability caused by or arising out of any actual or alleged act, error, or omission that occurred, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of commission employment, duties, or responsibilities; provided that nothing in this paragraph shall be construed to protect any such person from suit or liability for any damage, loss, injury, or liability caused by the intentional or willful or wanton misconduct of that person. The procurement of insurance of any type by the commission shall not in any way compromise or limit the immunity granted hereunder.
- (2) The commission shall defend any member, officer, executive director, employee, or representative of the commission in any civil action seeking to impose liability arising out of any actual or alleged act, error, or omission that occurred within the scope of commission employment, duties, or responsibilities, or as determined by the commission that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of commission employment, duties, or responsibilities; provided that nothing herein shall be construed to prohibit that person from retaining their own counsel at their own expense; and provided further that the actual or alleged act, error, or omission did not result from that person's intentional or willful or wanton misconduct.
- (3) Notwithstanding (G)(1) of this article, should any member, officer, executive director, employee, or representative of the commission be held liable for the amount of any settlement or judgment arising out of any actual or alleged act, error, or omission that occurred within the scope of that individual's employment, duties, or responsibilities for the commission, or that the person to whom that individual is liable had a reasonable basis for believing occurred within the scope of the individual's employment, duties, or responsibilities for the commission, the commission shall indemnify and hold harmless such individual; provided that the actual or alleged act, error, or omission did not result from the intentional or willful or wanton misconduct of the individual.

DATA SYSTEM (A) The commission shall provide for the development, maintenance, operation, and utilization of a coordinated database and reporting system containing licensure, adverse action, and the presence of significant investigative information on all licensees and applicants for a license in participating states. (B) Notwithstanding any other provision of state law to the contrary, a participating state shall submit a uniform data set to the data system on all individuals to whom this compact is applicable as required by the rules of the commission, including: (1) identifying information; (2) licensure data; (3) adverse actions against a licensee, license applicant, or compact privilege and information related thereto; (4) nonconfidential information related to alternative program participation, the beginning and ending dates of such participation, and other information related to such participation; (5) any denial of an application for licensure, and the reasons for such denial, excluding the reporting of any criminal history record information where prohibited by law; (6) the presence of significant investigative information; and (7) other information that may facilitate the administration of this compact or the protection of the public, as determined by the rules of the commission. (C) The records and information provided to a participating state pursuant to this compact or through the data system, when certified by the commission or an agent thereof, shall constitute the authenticated business records of the commission, and shall be entitled to any associated hearsay exception in any relevant judicial, quasi-judicial, or administrative proceedings in a participating state. (D) Significant investigative information pertaining to a licensee in any participating state will only be available to other participating states.

- (A) The commission shall promulgate reasonable rules in order to effectively and efficiently implement and administer the purposes and provisions of the compact. A commission rule shall be invalid and have no force or effect only if a court of competent jurisdiction holds that the rule is invalid because the commission exercised its rulemaking authority in a manner that is beyond the scope and purposes of the compact, or the powers granted hereunder, or based upon another applicable standard of review.
- (B) The rules of the commission shall have the force of law in each participating state, provided that where the rules of the commission conflict with the laws of the participating state that establish the participating state's scope of practice as held by a court of competent jurisdiction, the rules of the commission shall be ineffective in that state to the extent of the conflict.
- (C) The commission shall exercise its rulemaking powers pursuant to the criteria set forth in this article and the rules adopted thereunder. Rules shall become binding as of the date specified by the commission for each rule.
- (D) If a majority of the legislatures of the participating states rejects a commission rule or portion of a commission rule, by enactment of a statute or resolution in the same manner used to adopt the compact, within four years of the date of adoption of the rule, then such rule shall have no further force and effect in any participating state or to any state applying to participate in the compact.
  - (E) Rules shall be adopted at a regular or special meeting of the commission.
- (F) Prior to adoption of a proposed rule, the commission shall hold a public hearing and allow persons to provide oral and written comments, data, facts, opinions, and arguments.
