1.8	school diploma to a current or former Minnesota resident who is a veteran, was previously
1.9	enrolled in any high school in this state, and who:
1.10	(1) did not receive a high school diploma; and
1.11	(2) actively served in the United States armed services during World War II from 1939
1.12	through 1947, during the Korean war from 1950 through 1953, or during the Vietnam
1.13	conflict from 1961 through 1975; and
1.14	(i) died in active service;
1.15	(ii) was honorably discharged; or
1.16	(iii) was released from active duty because of a service-related disability.
1.17	(b) The commissioner of veterans affairs and the commissioner of education must jointly
