1.7	Subdivision 1. Issuance of plates. The commissioner must issue "Lions Clubs
1.8	International" special plates or a single motorcycle plate to an applicant who:
1.9	(1) is a registered owner of a passenger automobile, noncommercial one-ton pickup
1.10	truck, motorcycle, or recreational vehicle;
1.11	(2) pays a fee in the amount specified under section 168.12, subdivision 5, along with
1.12	any other fees required by this chapter;
1.13	(3) pays the registration tax as required under section 168.013;
1.14	(4) contributes a minimum of \$25 upon initial application and \$5 annually to the Lions
1.15	Clubs International account; and
1.16	(5) complies with this chapter and rules governing registration of motor vehicles and
1.17	licensing of drivers.
1.18	Subd. 2. Design. The commissioner must adopt a suitable plate design that includes the
1.19	recognized emblem of Lions Clubs International and the inscription "We Serve."
