report. 1.3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. STANDARDIZED ASSESSMENT TASK FORCE. 1.5 Subdivision 1. Establishment. The Standardized Assessment Task Force is established 1.6 to recommend to the Minnesota legislature changes to make Minnesota's standardized 1.7 assessment system more meaningful, reliable, and useful for schools, students, and families. 1.8 Subd. 2. Duties. (a) The Standardized Assessment Task Force must have the 2.3 following 14 members appointed by the commissioner of education: 2.4 2.5 (1) four teachers consisting of a special education teacher, a teacher of English as a second language, an elementary school teacher, and a secondary school teacher; 2.6 (2) one elementary school principal and one secondary school principal; 2.7 (3) two school testing coordinators; 2.8 2.9 (4) two superintendents or their designees; (5) two school board members or their designees; and 2.10 (6) two members of the assessment committee established by the Department of Education 2.11 to make recommendations on the state plan required under the Every Student Succeeds Act. 2.12 (b) The commissioner of education must establish an application process for membership 2.13 in the Standardized Assessment Task Force and must appoint members to the task force no 2.14 later than July 15, 2020.
