BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. APPROPRIATION; YOUTH PROGRAMMING.

\$2,000,000 in fiscal year 2023 is appropriated from the general fund to the commissioner of employment and economic development for a grant to the Community Action Partnership of Hennepin County, a 501(c)(3) nonprofit organization, working in conjunction with the Young People's Task Force of the Unity Community Mediation Team to provide economic development, mediation and reconciliation, conflict resolution, leadership, education, recreational, and individual self-growth programming for youth to be provided at the Rosa Parks Center for the Development of African-American Youth in Minneapolis. By February 1, 2024, the Community Action Partnership of Hennepin County shall report to the commissioner and the chairs and ranking minority members of the legislative committees with jurisdiction over economic development policy and finance on activities, expenditures, and outcomes of the programming offered at the youth center.
