2.9 (d) A special motorcycle license plate issued under this subdivision must be the
2.10 same size as a standard motorcycle license plate.

2.11 (e) Upon payment of a fee of \$5, plates issued under this subdivision for a passenger
2.12 automobile or truck may be transferred to another passenger automobile or truck owned
2.13 or jointly owned by the person to whom the plates were issued. On payment of a fee of
2.14 \$5, a plate issued under this subdivision for a motorcycle may be transferred to another
2.15 motorcycle owned or jointly owned by the person to whom the plate was issued.

2.16 (f) The commissioner may adopt rules under the Administrative Procedure Act,
2.17 sections 14.001 to 14.69, to govern the issuance and use of the special plates authorized
2.18 in this subdivision.

2.21 Subd. 2g. **Retired firefighters; special plates.** (a) The commissioner shall issue
2.22 special retired firefighters plates to an applicant who:

2.23 (1) is a retired member of a fire department defined in section 299N.01, subdivision
2.24 2, has a letter from the fire chief or administrative officer of the local government unit
2.25 or board with jurisdiction over the fire department affirming that the applicant is a
2.26 retired firefighter who served ten or more years and separated in good standing, and is
2.27 a registered owner of a passenger automobile, a one-ton pickup truck, a recreational
2.28 vehicle, or a motorcycle;

2.29 (2) pays a fee of \$10 for each set of license plates applied for along with any other
2.30 fees required by this chapter; and

2.31 (3) complies with this chapter and rules governing registration of motor vehicles
2.32 and licensing of drivers.

2.33 (b) The commissioner shall design the special plate emblem so that it is
2.34 distinguishable from the emblem on firefighter special plates issued under subdivision 2b.

3.1 (c) On payment of a transfer fee of \$5, plates issued under this subdivision may be
3.2 transferred to another passenger automobile, one-ton pickup truck, recreational vehicle, or
3.3 motorcycle registered to the individual to whom the special plates were issued.

3.4 (d) Fees collected under this subdivision must be credited to the vehicle services
3.5 operating account in the special revenue fund.

3.6 (e) This subdivision is exempt from section 168.1293.
