[299A.625] FIREARMS SAFETY TRAINING; REIMBURSEMENTS. 1.7 Subdivision 1. **Program established.** The commissioner of public safety may award 1.8 reimbursements to individuals who complete firearms safety training courses as provided 1.9 in subdivision 2. The commissioner shall develop standards addressing the procedures that 1.10 must be followed and the eligibility criteria to obtain a reimbursement. The commissioner 1.11 shall attempt to make the reimbursement process as simple as possible. In providing 1.12 reimbursements under this section, the commissioner may prioritize reimbursements to 1.13 individuals who demonstrate that they were previously inexperienced with or 1.14 unknowledgeable about firearms. 1.15 Subd. 2. Reimbursements. A person who completes a firearms safety training course 1.16 of the type described in section 624.714, subdivision 2a, may apply to the commissioner of 1.17 public safety in the manner directed by the commissioner for reimbursement of up to 50 1.18 percent of the cost of the course. 1.19

A 22 person, other than a federally licensed firearms dealer, who transfers a pistol or semiautomatic 2.3 military-style assault weapon to another without complying with the transfer requirements 2.4 of section 624.7132 or 624.7134, is guilty of a gross misdemeanor if the transferee possesses 2.5 or uses the weapon within one year after the transfer in furtherance of a felony crime of 2.6 violence, and if: 2.7 (1) the transferee was prohibited from possessing the weapon under section 624.713 at 2.8 the time of the transfer; or 2.9 (2) it was reasonably foreseeable at the time of the transfer that the transferee was likely 2.10 to use or possess the weapon in furtherance of a felony crime of violence. 2.11 **EFFECTIVE DATE.** This section is effective August 1, 2019, and applies to crimes 2.12 committed on or after that date. 2.13 Sec. 3.
