- (c) An organization receiving a grant under this section must use the grant funds for need-based scholarships and tuition reduction for students who meet Minnesota residency requirements in section 136A.101, subdivision 8.
- Subd. 3. Report required. By August 1 of each odd-numbered year, an organization receiving a grant under this section must submit to the Office of Higher Education and to the chairs and ranking minority members of the legislative committees with jurisdiction over higher education an annual report on the results of the grant. The report must include but is not limited to information about programs offered by the organization, program costs to students, student outcomes, the number of students served by the grant, and the average amount of scholarships or tuition reduction provided to students as a result of the grant.

## Sec. 2. <u>APPROPRIATION</u>; GRANTS TO SUPPORT INDIVIDUALS WITH LEARNING DIFFERENCES AND AUTISM SPECTRUM DISORDER.

\$4,000,000 in fiscal year 2023 is appropriated from the general fund to the commissioner
of the Office of Higher Education for grants to up to five eligible organizations under
Minnesota Statutes, section 136A.92.
