1.7	Subd. 5. Program funding. (a) In 2022, the public utility subject to section 116C.779
1.8	must withhold \$8,000,000 from the transfer made under section 116C.779, subdivision 1,
1.9	paragraph (e), to pay for assistance provided by the program under this section. In 2023,
1.10	the amount that must be withheld is \$4,300,000. In 2024, the amount that must be withheld
