1.9	before discharging a patient, a hospital must screen a patient who is uninsured or who does
1.10	not know the patient's insurance coverage status for eligibility for charity care from the
1.11	hospital, eligibility for state or federal public health care programs using presumptive
1.12	eligibility or another similar process, and eligibility for a premium tax credit.
1.13	(b) If the patient is eligible for charity care from the hospital, the hospital must assist
1.14	the patient in applying for charity care and must refer the patient to the appropriate
1.15	department in the hospital for follow-up.
1.16	(c) If the patient is presumptively eligible for a public health care program, the hospital
1.17	must assist the patient in completing an insurance affordability program application or must
