Of the amount 2.13 transferred to the Board of Regents, up to 2.14 \$1,000,000 each year is for research on avian 2.15 influenza, salmonella, and other turkey-related 2.16 diseases. The grant money must be used to replace or upgrade equipment that does not 5.9 have the ability to be certified for E25. A grant 5.10 award must not exceed 65 percent of the cost 5.11 of the appropriate technology. A grant award 5.12 must not exceed \$200,000 per station. The 5.13 commissioner must cooperate with biofuel 5.14 stakeholders in the implementation of the grant 5.15 program. The commissioner, in cooperation 5.16 with any economic or community development 5.17 financial institution and any other entity with 5.18 which it contracts, must submit a report on the 5.19 biofuels infrastructure financial assistance 5.20 program by January 15 of each year to the 5.21 chairs and ranking minority members of the 5.22 legislative committees and divisions with 5.23 jurisdiction over agriculture policy and 5.24 finance.
