(a) Notwithstanding section 297G.07, subdivision 2, or any provision of this chapter,
a winery or brewery licensed in a state other than Minnesota, or a winery located in
Minnesota, may ship, for personal use and not for resale, not more than two cases of wine,
containing a maximum of nine liters per case, or not more than two cases of malt liquor,
containing a maximum of 288 ounces per case, in any calendar year to any resident of
Minnesota age 21 or over. Delivery of a shipment under this section may not be deemed
a sale in this state.

(b) The shipping container of any wine <u>or malt liquor</u> sent under this section must be
clearly marked "Alcoholic Beverages: adult signature (over 21 years of age) required."
(c) It is not the intent of this section to impair the distribution of wine <u>or malt liquor</u>
through distributors or importing distributors, but only to permit shipments of wine <u>or</u>

(d) No criminal penalty may be imposed on a person for a violation of this section 2.21 other than a violation described in paragraph (e) or (f). Whenever it appears to the 2.22 commissioner that any person has engaged in any act or practice constituting a violation 2.23 of this section, and the violation is not within two years of any previous violation of 2.24 this section, the commissioner shall issue and cause to be served upon the person an 2.25 order requiring the person to cease and desist from violating this section. The order must 2.26 give reasonable notice of the rights of the person to request a hearing and must state the 2.27 reason for the entry of the order.
