1.8	This act may be cited as the "Pain-Capable Unborn Child Protection Act."

1.10	(a) There is created a special revenue fund known as the Pain-Capable Unborn Child
1.11	Protection Act litigation fund for the purpose of providing funds to pay for any costs and

1.14	(b) The fund shall be maintained by the state Office of Management and Budget.
1.15	(c) The litigation fund shall consist of:

4.26	Sec. 5. [145.4142] LEGISLATIVE FINDINGS.
4.27	(a) The legislature makes the following findings.
4.28	(b) Pain receptors (nociceptors) are present throughout an unborn child's entire body
4.29	by 16 weeks after fertilization and nerves link these receptors to the brain's thalamus
4.30	and subcortical plate by 20 weeks.
4.31	(c) By eight weeks after fertilization, an unborn child reacts to stimuli that would be
4.32	recognized as painful if applied to an adult human, for example by recoiling.
4.33	(d) In the unborn child, application of such painful stimuli is associated with
4.34	significant increases in stress hormones known as the stress response.

5.1	(e) Subjection to such painful stimuli is associated with long-term harmful
5.2	neurodevelopmental effects, such as altered pain sensitivity and, possibly, emotional,
5.3	behavioral, and learning disabilities later in life.
5.4	(f) For the purposes of surgery on an unborn child, fetal anesthesia is routinely
5.5	administered and is associated with a decrease in stress hormones compared to the level
5.6	when painful stimuli is applied without anesthesia.
5.7	(g) The position, asserted by some medical experts, that an unborn child is incapable
5.8	of experiencing pain until a point later in pregnancy than 20 weeks after fertilization
5.9	predominately rests on the assumption that the ability to experience pain depends on the
5.10	cerebral cortex and requires nerve connections between the thalamus and the cortex.
5.11	However, recent medical research and analysis, especially since 2007, provides strong
5.12	evidence for the conclusion that a functioning cortex is not necessary to experience pain.
5.13	(h) Substantial evidence indicates that a child born missing the bulk of the cerebral
5.14	cortex, those with hydranencephaly, nevertheless experience pain.
5.15	(i) In adults, stimulation or ablation of the cerebral cortex does not alter pain
5.16	perception, while stimulation or ablation of the thalamus does.
5.17	(j) Substantial evidence indicates that structures used for pain processing in early
5.18	development differ from those of adults, using different neural elements available at
5.19	specific times during development, such as the subcortical plate, to fulfill the role of
5.20	pain processing.
5.21	(k) There is substantial medical evidence that an unborn child is capable of
5.22	experiencing pain by 20 weeks after fertilization.
5.23	(1) It is the purpose of the state to assert a compelling state interest in protecting the
5.24	lives of unborn children from the stage at which substantial medical evidence indicates
5.25	that they are capable of feeling pain.
5.26	Sec. 6. [145.4143] DETERMINATION OF GESTATIONAL AGE.
5.27	Subdivision 1. Determination of postfertilization age. Except in the case of a
5.28	medical emergency, no abortion shall be performed or induced or be attempted to be
5.29	performed or induced unless the physician performing or inducing it has first made a
5.30	determination of the probable postfertilization age of the unborn child or relied upon
5.31	such a determination made by another physician. In making such a determination, the
5.32	physician shall make inquiries of the woman and perform or cause to be performed

6.3 Sec. 7. [145.4144] ABORTION OF UNBORN CHILD OF 20 OR MORE WEEKS 6.4 GESTATIONAL AGE PROHIBITED; CAPABLE OF FEELING PAIN.

Subdivision 1. Abortion prohibition; exemption. No person shall perform or 6.5 induce or attempt to perform or induce an abortion upon a woman when it has been 6.6 determined, by the physician performing or inducing or attempting to perform or induce 6.7 the abortion, or by another physician upon whose determination that physician relies, 6.8 that the probable postfertilization age of the woman's unborn child is 20 or more weeks 6.9 unless, in reasonable medical judgment, she has a condition which so complicates her 6.10 medical condition as to necessitate the abortion of her pregnancy to avert her death or to 6.11 avert serious risk of substantial and irreversible physical impairment of a major bodily 6.12 function not including psychological or emotional conditions. No such condition shall 6.13 be deemed to exist if it is based on a claim or diagnosis that the woman will engage 6.14 in conduct which would result in her death or in substantial and irreversible physical 6.15 impairment of a major bodily function. 6.16 Subd. 2. When abortion not prohibited. When an abortion upon a woman whose 6.17 unborn child has been determined to have a probable postfertilization age of 20 or more 6.18 weeks is not prohibited by this section, the physician shall terminate the pregnancy in 6.19 the manner which, in reasonable medical judgment, provides the best opportunity for 6.20 the unborn child to survive unless, in reasonable medical judgment, termination of the 6.21 6.22 pregnancy in that manner would pose a greater risk either of the death of the pregnant woman or of the substantial and irreversible physical impairment of a major bodily 6.23 function, not including psychological or emotional conditions, of the woman than would 6.24 other available methods. No such greater risk shall be deemed to exist if it is based on a 6.25 claim or diagnosis that the woman will engage in conduct which would result in her death 6.26 or in substantial and irreversible physical impairment of a major bodily function. 6.27

6.28 Sec. 8. [145.4145] ENFORCEMENT.
6.29 Subdivision 1. Criminal penalties. A person who intentionally or recklessly
6.30 performs or induces or attempts to perform or induce an abortion in violation of sections
6.31 145.4141 to 145.4148 shall be guilty of a felony. No penalty may be assessed against the
6.32 woman upon whom the abortion is performed or induced or attempted to be performed or
6.33 induced.

7.1	Subd. 2. Civil remedies. (a) A woman upon whom an abortion has been performed
7.2	or induced in violation of sections 145.4141 to 145.4148, or the father of the unborn child
7.3	who was the subject of such an abortion, may maintain an action against the person who
7.4	performed or induced the abortion in intentional or reckless violation of sections 145.4141
7.5	to 145.4148 for actual and punitive damages. A woman upon whom an abortion has been

7.9	(b) A cause of action for injunctive relief against a person who has intentionally

7.12	sections 145.4141 to 145.4148; by a person who is the father of the unborn child subject
7.13	to an abortion, parent, sibling, or guardian of, or a current or former licensed health
7.14	care provider of, the woman upon whom an abortion has been performed or induced or
7.15	attempted to be performed or induced in violation of sections 145.4141 to 145.4148; by a
7.16	county attorney with appropriate jurisdiction; or by the attorney general. The injunction
7.17	shall prevent the abortion provider from performing or inducing further abortions in this
7.18	state in violation of sections 145.4141 to 145.4148.
7.19	(c) If judgment is rendered in favor of the plaintiff in an action described in this
7.20	section, the court shall also render judgment for reasonable attorney fees in favor of
7.21	the plaintiff against the defendant.
7.22	(d) If judgment is rendered in favor of the defendant and the court finds that the
7.23	plaintiff's suit was frivolous and brought in bad faith, the court shall also render judgment
7.24	for reasonable attorney fees in favor of the defendant against the plaintiff.
7.25	(e) No damages or attorney fees may be assessed against the woman upon whom
7.26	an abortion was performed or induced or attempted to be performed or induced except
7.27	according to paragraph (d).
7.28	Sec. 9. [145.4146] PROTECTION OF PRIVACY IN COURT PROCEEDINGS.
7.29	In every civil or criminal proceeding or action brought under the Pain-Capable
7.30	Unborn Child Protection Act, the court shall rule on whether the anonymity of a woman
7.31	upon whom an abortion has been performed or induced or attempted to be performed
7.32	or induced shall be preserved from public disclosure if she does not give her consent
7.33	to such disclosure. The court, upon motion or sua sponte, shall make such a ruling
7.34	and, upon determining that her anonymity should be preserved, shall issue orders to the
7.35	parties, witnesses, and counsel and shall direct the sealing of the record and exclusion of

individuals from courtrooms or hearing rooms to the extent necessary to safeguard her 8.1 8.2 identity from public disclosure. Each such order shall be accompanied by specific written findings explaining why the anonymity of the woman should be preserved from public 8.3 disclosure, why the order is essential to that end, how the order is narrowly tailored to 8.4 serve that interest, and why no reasonable, less restrictive alternative exists. In the absence 8.5 of written consent of the woman upon whom an abortion has been performed or induced 8.6 or attempted to be performed or induced, anyone, other than a public official, who brings 8.7 an action under section 145.4145, subdivision 2, shall do so under a pseudonym. This 8.8 section may not be construed to conceal the identity of the plaintiff or of witnesses from 8.9 the defendant or from attorneys for the defendant. 8.10

8.11 Sec. 10. [145.4147] SEVERABILITY. If any one or more provisions, sections, subsections, sentences, clauses, phrases, 8.12 or words of sections 145.4141 to 145.4148, or the application thereof to any person or 8.13 8.14 circumstance is found to be unconstitutional, the same is hereby declared to be severable and the balance of sections 145.4141 to 145.4148 shall remain effective notwithstanding 8.15 such unconstitutionality. The legislature hereby declares that it would have passed 8.16 sections 145.4141 to 145.4148, and each provision, section, subsection, sentence, clause, 8.17 phrase, or word thereof, irrespective of the fact that any one or more provisions, sections, 8.18 subsections, sentences, clauses, phrases, or words of sections 145.4141 to 145.4148, or the 8.19 application of sections 145.4141 to 145.4148, would be declared unconstitutional. 8.20 Sec. 11.
