1.6	Section 1. Minnesota Statutes 2020, section 3.055, subdivision 1, is amended to read:
1.7	Subdivision 1. Meetings to be open. (a) Meetings of the legislature shall be open to the
1.8	public, including sessions of the senate, sessions of the house of representatives, joint
1.9	sessions of the senate and the house of representatives, and meetings of a standing committee,
1.10	committee division, subcommittee, conference committee, or legislative commission, but
1.11	not including a caucus of the members of any of those bodies from the same house and
1.12	political party nor a delegation of legislators representing a geographic area or political
1.13	subdivision. For purposes of this section, a meeting occurs when a quorum is present and
1.14	action is taken regarding a matter within the jurisdiction of the body.
1.15	(b) In addition to the openness requirements imposed on conference committees by
1.16	paragraph (a), from the time a conference committee is appointed until it is disbanded, any
1.17	negotiations between senate and house of representatives members of the conference
1.18	committee or senate and house of representatives staff members related to the conference
1.19	committee or the bill referred to the conference committee must be open to the public.
1.20	(c) A meeting between the majority leader of the senate and the speaker of the house or
1.21	the majority leader of the house of representatives to negotiate budget targets or formally
1.22	negotiate the state budget must be open to the public.
