OFFICIAL STATUS

1.1 A bill for an act
1.2 relating to taxation; lawful gambling; reducing rates for the combined net receipts
1.3 tax and providing a deduction for lawful purpose expenditures; amending Minnesota
1.4 Statutes 2018, section 297E.02, subdivision 6.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2018, section 297E.02, subdivision 6, is amended to read:

1.7 Subd. 6. **Combined net receipts tax.** (a) In addition to the taxes imposed under
1.8 subdivision 1, a tax is imposed on the combined net receipts of the organization. As used
1.9 in this section, "combined net receipts" is the sum of the organization's gross receipts from
1.10 lawful gambling less gross receipts directly derived from the conduct of paper bingo, raffles,
1.11 and paddlewheels, as defined in section 297E.01, subdivision 8, ~~and~~ less the net prizes
1.12 actually paid, other than prizes actually paid for paper bingo, raffles, and paddlewheels, and
1.13 less the amounts actually expended for lawful purpose contributions under section 349.12,
1.14 subdivision 25, paragraph (a), clauses (1) to (7) and (9) to (26), for the fiscal year. The
1.15 combined net receipts of an organization are subject to a tax computed according to the
1.16 following schedule:

 2.9 ~~exceeds \$94,800,000, the commissioner shall certify that effective July 1, 2016, the rates~~

2.24 ~~(e)~~ (b) Gross receipts derived from sports-themed tipboards are exempt from taxation
 2.25 under this section. For purposes of this paragraph, a sports-themed tipboard means a
 2.26 sports-themed tipboard as defined in section 349.12, subdivision 34, under which the winning
 2.27 numbers are determined by the numerical outcome of a professional sporting event.

2.28 **EFFECTIVE DATE.** This section is effective July 1, 2019.
